RE: Request to de-authorize SJ-4301 POD 1 (NW/4 NE/4 Sec 16, T22N R7W, NMPM) as a
production well pursuant to NMSA 1978, Sections 72-12-25 through 72-12-28

Dear Mr. Campbell:

This letter concerns the New Mexico Office of the State Engineer (OSE) authorization for production AND the jurisdictional authority for Permit SJ-4301 POD 1. On Oct 13, 2023, Enduring Resources stated via letter (see attached) that they will cease appropriating water from this well and relinquish authority to appropriate water as granted by OSE in a letter dated December 10, 2018.

The Oil Conservation Division (OCD) issued ORDER Granting UIC Permit SWD-2509 dated October 20, 2023 (see attached). The OCD authorized the use of OSE permitted well SJ-4301 POD 1 as an UIC Class II fluids injection well under OCD UIC Permit SWD-2509. This UIC permit does have a Special Condition (#1) on page 13 of 14 of said Permit, that the applicant "provide written confirmation of the relinquishment of the Well's authority as a point of diversion..." prior to use of subject well for injection(s).

Therefore, upon this date, May 22, 2024, the New Mexico Office of the State Engineer hereby de-authorizes the use of SJ-4301 POD 1 for groundwater diversions and relinquishes authority over the subject well to the Oil Conservation Division of the Energy, Minerals and Natural Resources Department of the State of New Mexico.

Please submit the final meter reading and date thereof for SJ-4301 POD 1 if not already of done so.
