

- 4. Release TAC, RIH and tagged fill, and scanned tubing OOH.
- 5. RIH with bit and scraper to PBTD.
- 6. Cleaned perforations with 5000 gallons of 15% NeFe acid.
- 7. RIH with redressed TAC, tubing, pump and rod string configuration. Set TAC @ 3677'.
- 8. Loaded and tested tubing held.
- 9. RDMO on 06/04/2024.
- 10. Notified NMOCD.
- 11. RWTP.
