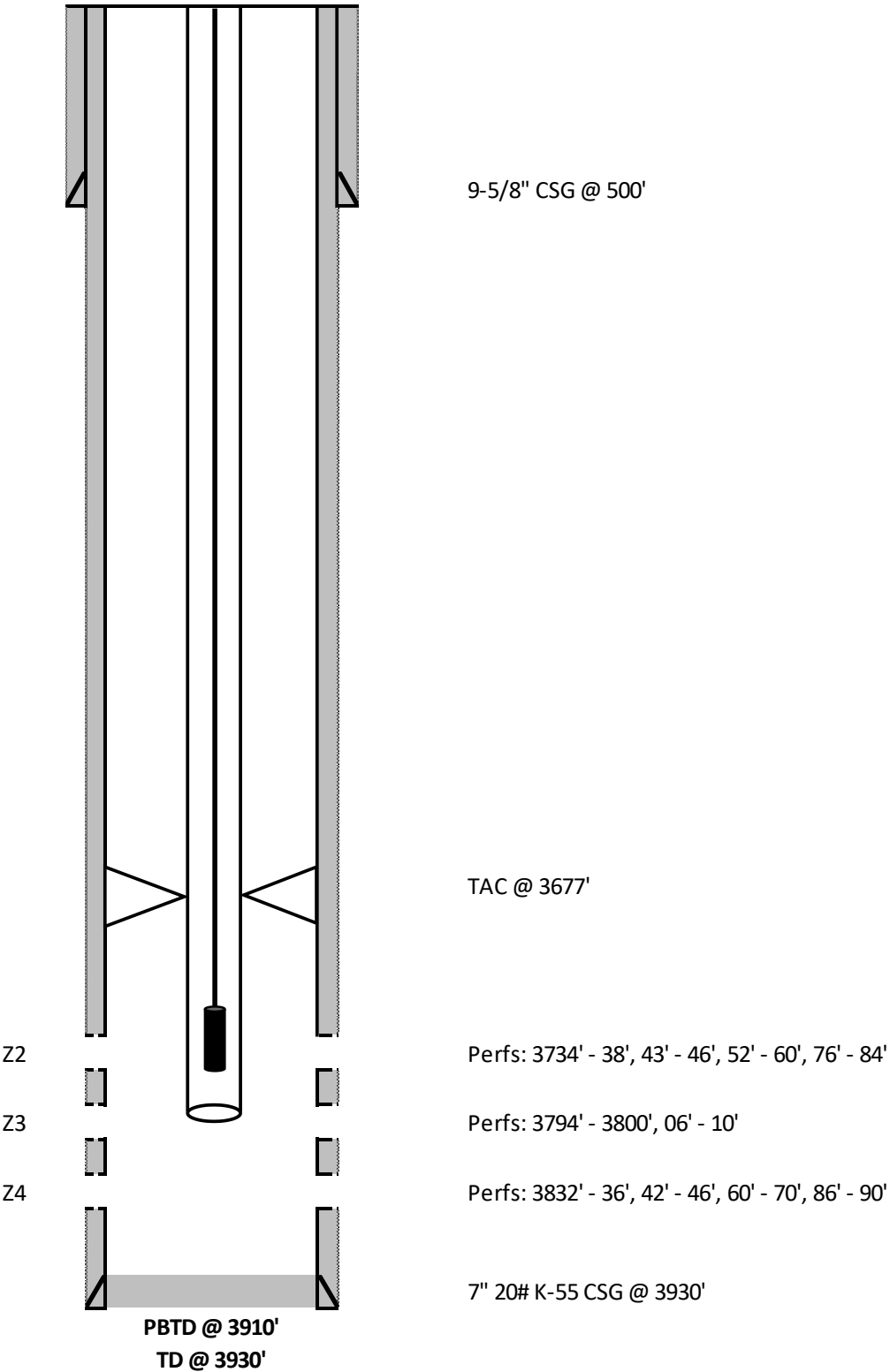

5. RIH with bit and scraper to PBTD.
6. Cleaned perforations with 5000 gallons of 15% NeFe acid.
7. RIH with redressed TAC, tubing, pump and rod string configuration. Set TAC @ 3677'.
8. Loaded and tested tubing - held.
9. RDMO on 06/04/2024.
10. Notified NMOCD.
11. RWTP.
