Hi Gene and Nina,

BLM records show the well name corresponding with API number 30-045-34767 and the location you sent as the Bisti Otero 30 #1E.

The well history is as follows:

- Application for Permit to Drill (APD) for this well was approved October 28, 2008 by the BLM Farmington office.
- A 2-year extension to the permit was granted October 14, 2010 by the BLM Farmington

office.

- The APD expired on its terms October 28, 2012.
- No notifications of construction or any type of drilling activity were received by our office. Satellite imagery shows the permitted well pad was never constructed (surface is largely unchanged since at least 1997).
- As the APD is expired and no construction or other activity occurred as a result of the permit, BLM does not require any further action on this well.
