**Procedure Description:** XTO Permian Operating, LLC. respectfully requests to construct, operate and maintain a sixty (60) foot wide and one hundred (100) foot wide easement containing up to forty eight (48) 20" or less buried composite flexpipe or steel flowlines with a maximum safety pressure rating of 1400 psi (operating pressure 750 psi) for transportation of oil, gas, frac water, gas lift, fuel gas and produced water are requested to the Poker Lake Unit 30 CTB West and Poker Lake Unit 30 CTB East batteries. The proposed corridor for the flowlines is the same corridor as previously approved in the APD, with the exception of showing the lateral into the Tank Battery along existing surface disturbance. 794.62' long and 60' wide for a total of 0.89 acres and 7917.94' long and 100' wide for a total of 17.95 acres. Total length: 8712.56' long and 18.84 acres. Flowline corridor is located in Section 30 of Township 25 South and Range 31 East, Eddy County, New Mexico. 

