

**Procedure:**

1. MIRU P&A rig.
2. MIRU WLU and ran CBL from 2027' – surface. Cement bridge: 1500' – 1528' but no cement in the rest of the string.
3. Spot 85 sks of Class C cement @ 2189'. WOC & tried to tag but did not encounter cement.
4. Spot 85 sks of 2% calcium chloride @ 2189'. WOC & tagged @ 1965'.
5. RIH w/ tbg and tagged 1965'. Spot 65 sks on top. WOC & tagged @ 1331'.
6. Pressure tested casing to 500 psi – held.
7. Perf'd & sqz'd 50 sks class C cmt @ 1319' (T/Salt est.). WOC & tagged @ 1060'.
8. Perf'd & sqz'd 120 sks class C cmt @ 378' – surface. WOC & found cement @ surface.
9. RDMO P&A rig on 07/26/2025.
10. Notified BLM/NMOCD.
11. Dug out around wellhead and cut. Welded DHM and cleaned location.
