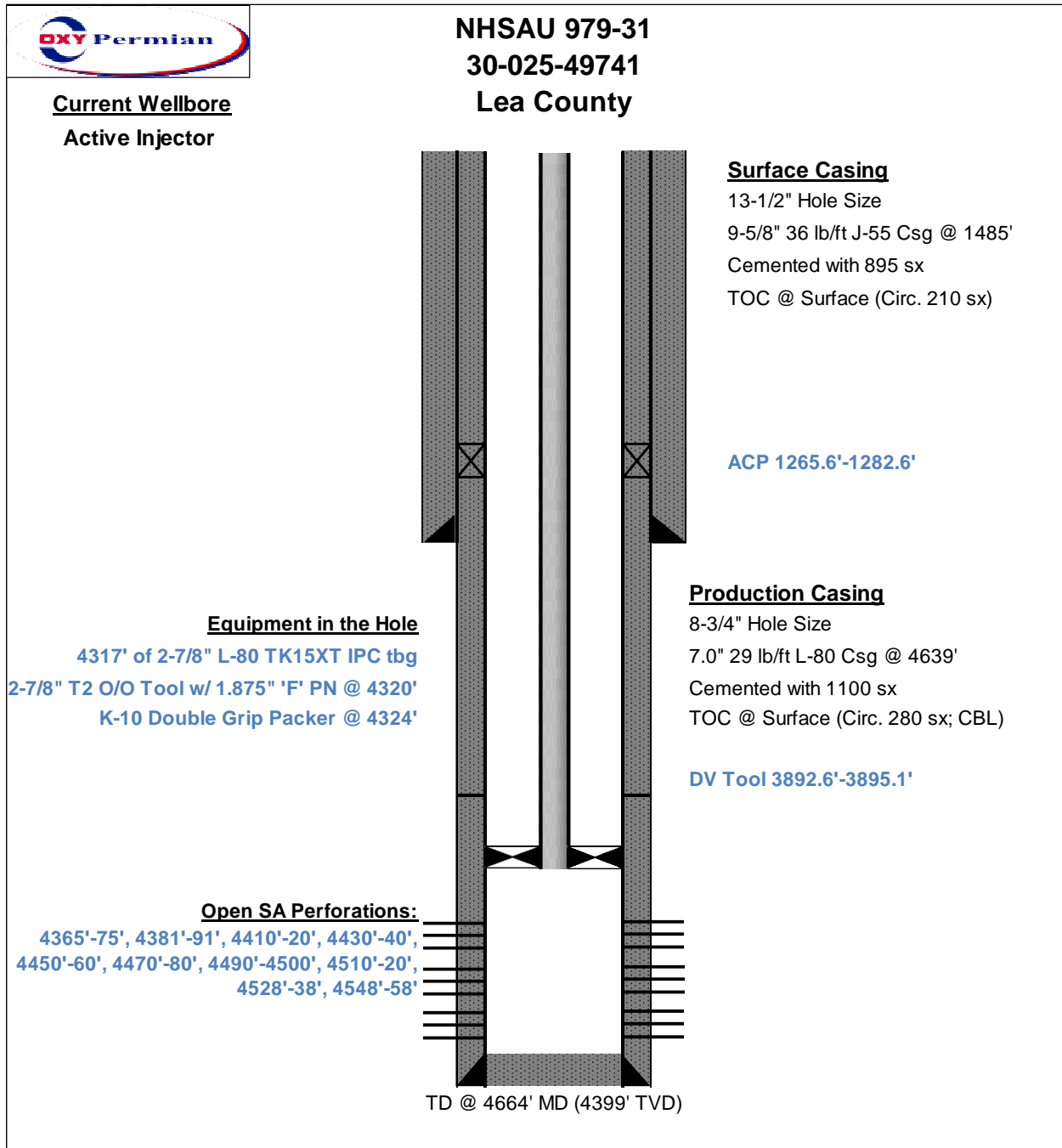

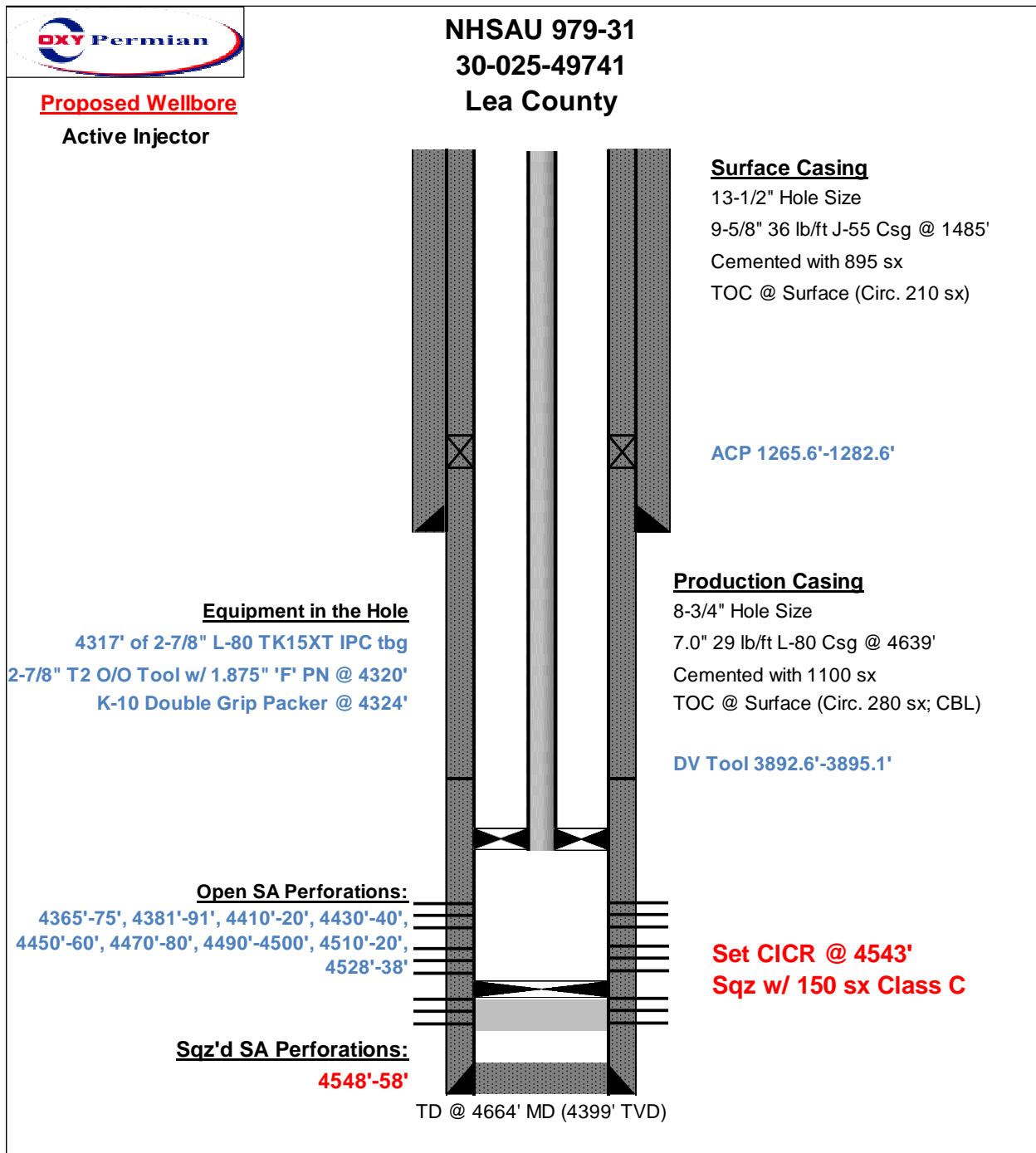
Objective: Set CICR & Cement Squeeze lower perforations to shut-off behind pipe channeling into Zn3H

Job Plan:

- Pull injection equipment.
- Set CICR ~4534'. Test casing to 500#.
- Sqz perfs f/ 4548-58' w/ ~150 sx Class C cmt. Wait on Cement.
- Isolate & injectivity test perfs above CICR. Reperforate and acid treat interval f/ 4365'-4528' if necessary.
- Install injection equipment.
- Return well to injection.
