



- 4) RU WL x Reperforate wellbore from ~4052' - ~4205' x RD WL
- 5) RIH w/ 7.0" PPI tool
- 6) Acid stimulate well with ~4,000 gal 15% HCL
 - Max rate = 4-5 BPM
- 7) Flush acid with ~200 bbls off fresh water
- 8) POOH LD PPI tool
- 9) RIH with injection equipment.
- 10) RD PU. Put well on injection.
