Proposed Cement Remediation Procedure - NOI San Juan 27-5 Unit NP 330 Sidetrack API # - 3003925522

Procedure:

Hold PJSM prior to beginning all operations. Properly document all operations via the JSA process. Ensure that all personnel onsite abide by HEC safety protocol, including PPE, housekeeping, and standard guidelines.

Verify cathodic protection is off and wellhead instrumentation is properly disconnected from the wellhead. Comply with all NMOCD, BLM, and HEC safety and environmental regulations.

Observe and record pressures across all string daily, prior to beginning operations. **Notify NMOCD 24 hours prior to starting operations on location.**

Mesa Verde remediation sqz:

- 1. MIRU WL. RIH and perforate squeeze hole at **5900'**. TOOH with WL tools.
- 2. RIH and set CICR on tbg at 5880'.
- 3. Shoot upper sqz hole at **5400'.** Establish circulation. RU cement crew, establish injection, and perform circulating squeeze.
- 4. Sting out of retainer, reverse out any residual cmt, wait on cement to cure.

Post sqz work:

- 1. RIH with bit, drillout CICRs and all residual cmt.
- 2. RU WL and pull CBL.
- 3. Continue with MV completion prep.
