

- MI & RU Aztec Well Services Rig 481 and cement equipment.
- Check pressures, Tubing 170 psi, Casing 20 psi, BH 0 psi. ND WH & NU BOP.
- TOOH w/1½" production tubing. PU and tally 2-3/8" tubing for workstring.
- Run 4½" casing scraper to 1562'. RIH & set 4½" CIBP @ 1558'. Chacra perforations @ 1608'-1688'.
- Load and circulate hole. Attempted to pressure test casing to 600 psi for 30 mins. Casing won't test.
- Check pressures, Tubing 0 psi, Casing 0 psi, BH 0 psi.
- Run CBL from 1558' to surface. Sent copy of CBL to NMOCD/BLM.
- Spot inside Plug I inside 4½" casing above CIBP @ 1558' w/ 42 sks (48.3 cu ft) Class G neat cement (5 gal/sk, 15.8 #/gal, 1.15 cu ft/sk) to cover the Chacra & Pictured Cliffs tops.
