MU 8.5" bit, TIH t/3000' w/ DV tool DO assembly. Tag@ 3463'. DO #1 & 2 DVT plugs @ 4549' & 3464'. PT 9-5/8" casing, 1600psi/30min. Displace hole w/ OBM Drill out cmt, shoe track f/5994' t/6131'. FC @ 6045', shoe @ 6131'. CO out rat hole t/6153'. Drill 10' new hole to 6163'. Circ hole clean. Perform FIT. POOH. TIH P/U Directional BHA. Drill 8.5" f/6163 t/6234', rotate and slide drill 8.5" f/6234' t/6441'. 8/31- 9/3/2024 - Continue to drill 8.5" f/6441' t/6749'. Trouble shoot pipe handler on top drive. Repair same. Rotate & slide drill 8.5" f/6749' t/16352' (TD). Perform clean up cycle. Circulate and condition. 9/4/24- Continue to circulate and clean up cycle. POOH, lay down BHA. 9/5-9/6/2024 - RU CRT. RIH w/363jts of 5.5" 20#, HCP-110, BTC csg set @ 16,322'. Top of FS @ 16,319', w/FC @ 16,228'. Toe sleeves @ 16,135' & 16,087'. Circulate & condition. Pump 142sxs cmt (45bbbls, 254cf) cap isobond lead #1 cmt, 12.5 ppg, 1.79 yield. Pump 605sxs lead #2 cmt (193.5bbbls, 1089cf) w/ Super CBL. 12.5 ppg, 1.80yld. Tail w/1216sxs (429bbbls, 2408cf) NEOCEM tail cmt,13.2ppg, 1.98yld.Displace with 359.9 bbbls of water w/ Retarder in first 40bbbls. Bumped plug to 2600 psi. 500 over circulating pressure. Held for 5 min, bled back 3.5 bbbls to check floats (Floats Held). No spacer to surface/ Estimated 308bbbls of lost OBM to well. Flow check on backside (no flow). Partial losses was seen 50bbbls in to tail cement, Opened MPD Choke to Full open Regained Full Return after 80bbbls. continued job with full returns. Shut Down and Dropped Top Plug and Started Displacement @ 5bbbls/min for 130bbbls returns dropped to 3.5bbl/min, slowed pump rate to 4bbbls/min down to 3 bbl/min for 100bbbls with Partial returns. Slowed pump rate to 2bbbls/min from 230bbbls to 330bbbls with no returns to surface. Upped pump rate to 3bbbls/min for last 30bbbls to land plug. Total Estimated mud lost 308bbbls.
