

10/8/2024 – MIRU plugging rig & equipment. Notified David Alvarado w/NMOCD. 10/9/2024 – POOH w/rods. ND WH & NU BOP. Unable to get tbg to come free. Pumped 7 BBW down tbg & pressured up. 10/10/2024 - MIRU HO unit. Pumped 5 BHFw down tbg & pressured up. Pumped 40 BHFw down 5 ½" x 2 3/8" annulus. Tbg came free. POOH w/tbg. RU swivel. RIH w/4 ¾" bit & got to 2674'. 10/11/2024 – Unable to make additional hole. POOH w/bit. Cleaned bit & RIH. Broke circulation & got to 2736'. RD swivel. Start POOH w/tbg. 10/14/2024 – Finished POOH w/tbg. RIH w/CIBP on tbg. Set CIBP @ 2733'. Circulated well w/MLF. Leak tested 5 ½" csg to 500# for 30 minutes, held OK. MIRU WL. Ran CBL from 2733' to surface. Located TOC @ 2304'. POOH w/WL. RIH w/tbg to 2733'. Spotted 45 sks Class C neat cmt on top of CIBP. POOH w/tbg & WOC. 10/15/2024 – RIH w/tbg & tagged TOC @ 2287'.
