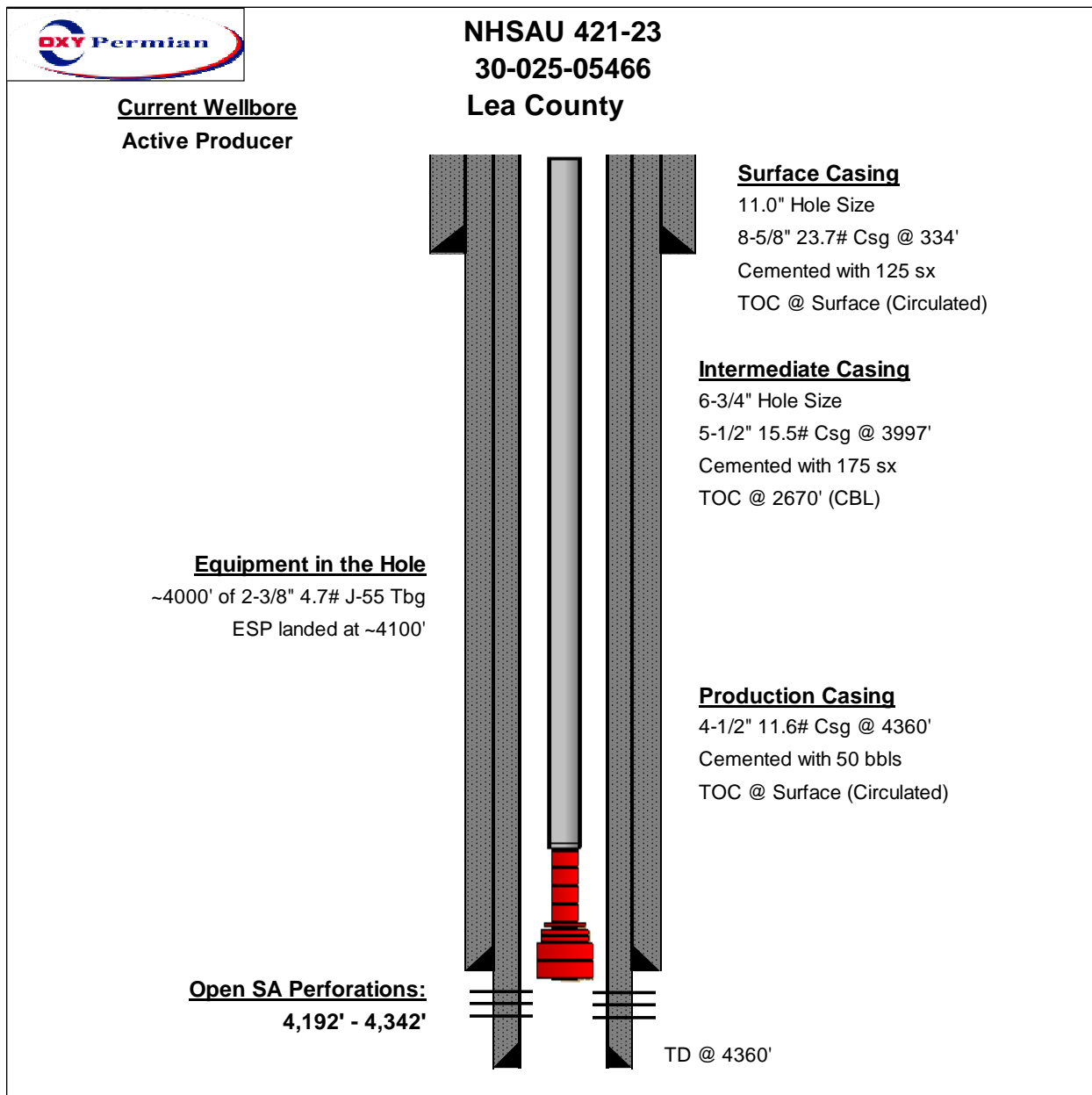

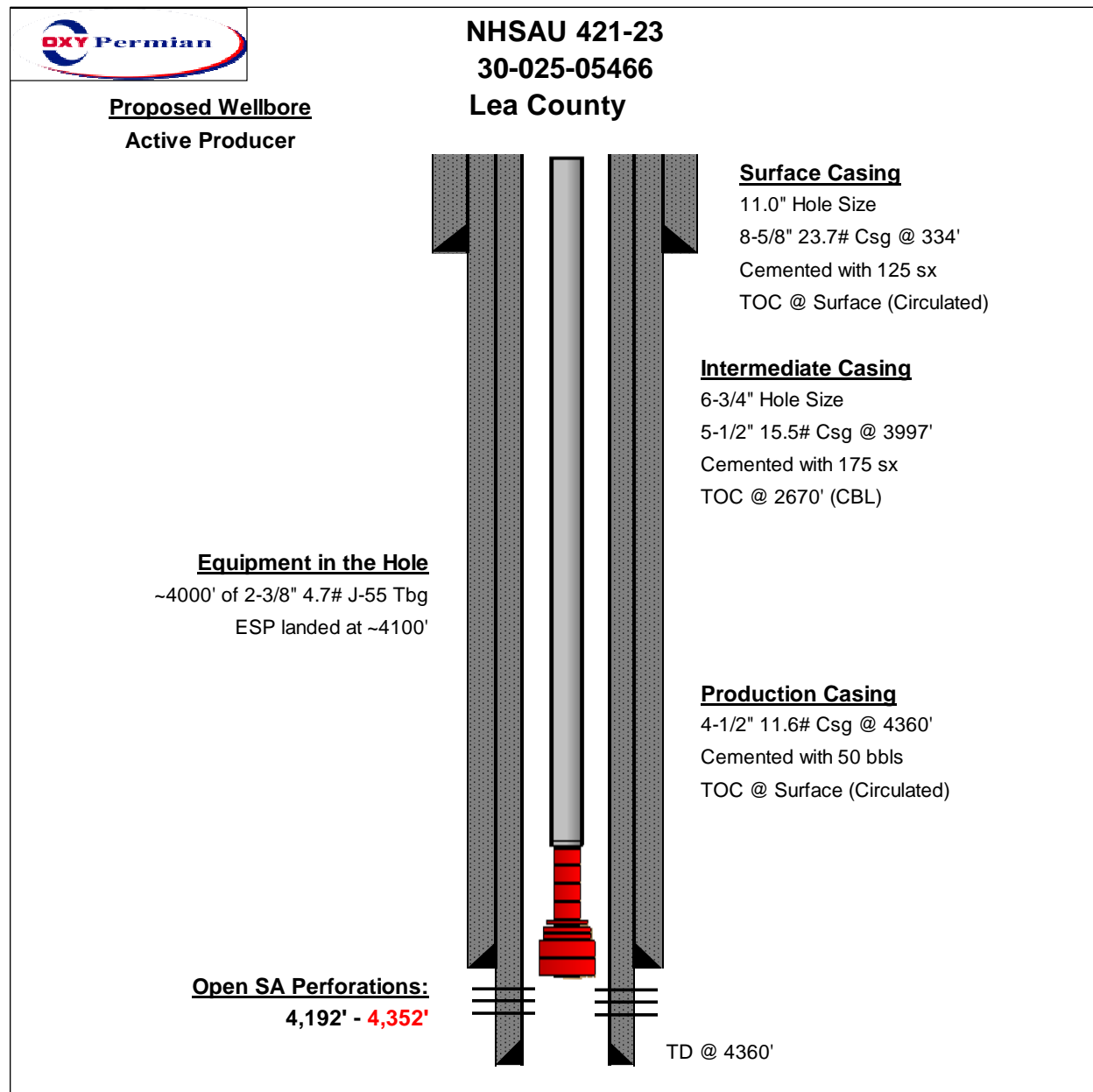

5. Cleanout well to TD at 4360'
6. RU WL
7. Perforate 4.5" csg from 4342'-4352' & 4238'-4248'
8. RD WL
9. Spot 150 gal 15% HCL acid across perforations
10. Acidize new and existing perforations with packer and plug in 4 stages.
11. Run slimline ESP Eqpt
12. RD PU
13. Return well to production
