Vacuum Glorieta East Unit 024-03 TA Procedure

1. MIRU WOR & equipment.
2. ND WH. Function test BOPs. NU BOPs and annular.
3. Pick up on hanger. Cut cable and test below hanger.
4. RU cable spooler.
5. POOH with tubing, ESP, and cable. Note condition of tubing, ESP, and cable.
6. RIH with tubing and scan out of hole.
7. Set CIBP within 50' of top perforation at 6,052'.
8. Bail 35' of cement on top of plug.
9. TIH to tag top of cement. POOH with tubing.
10. Perform pressure test to verify integrity.
11. RDMO WOR & equipment.

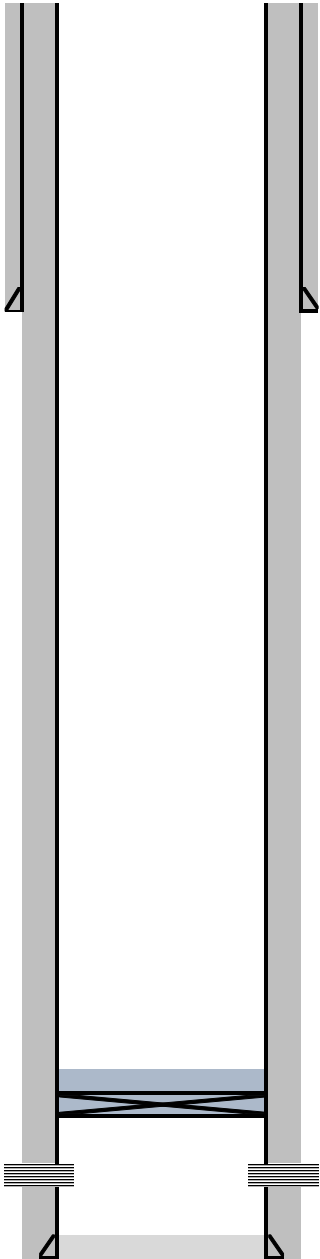

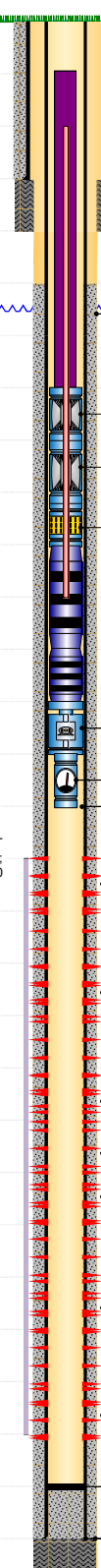

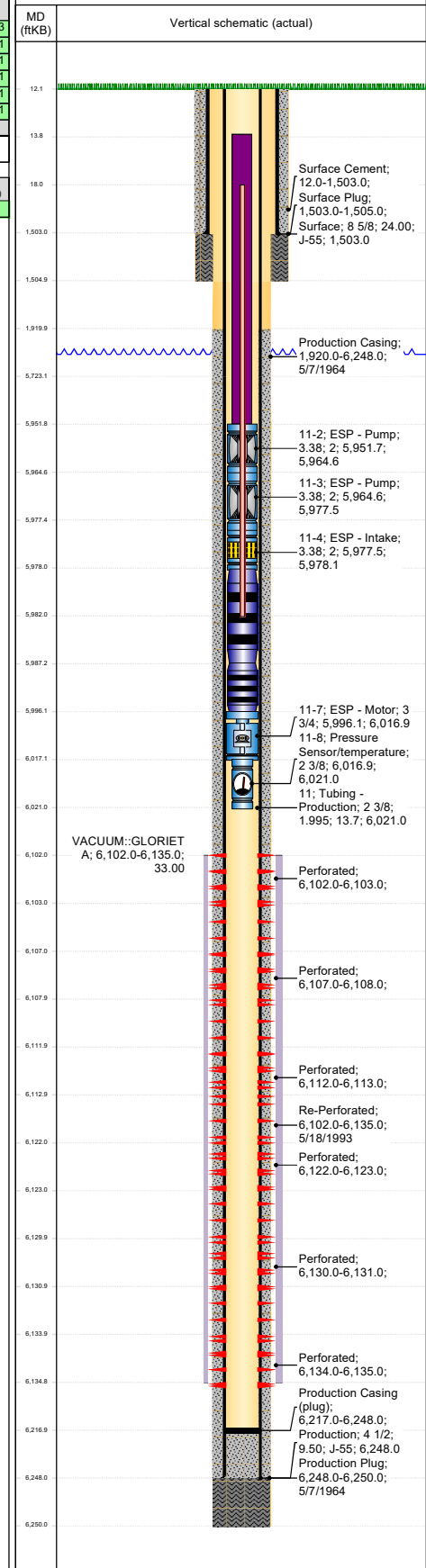
