3/3 - Run 9-5/8", 40#, P110, BTC casing to 3175'. Cement casing with 540 sks, 2.13 yield, Class C lead cement and 380 sks, 1.32 yield, Class C tail cement with 102 bbls of cement circulated to surface. Pressure test casing to 4000 psi for 30 min, held, good test. Skid rig off.

3/9 - Run 7-5/8", 29.7#, P110, FJM, casing to 8753'. Cement casing with 470 sks, 3.03 yield, Class C lead cement and 150 sks, 1.28 yield, Class C of tail cement with 81 bbls of cement circulated to surface. Pressure test casing to 2850 psi for 30 min, held, good test. Skid Rig off.
