Actual Procedure: The Dominator 25 Federal Com #1H can produce oil and gas in paying quantities but will be shut in to avoid potential spills and line strikes. The neighboring pads to the east and west will have new wells drilled on them. The neighboring pads to the east and west share electrical infrastructure with this well that will be shut down to prevent line strikes during drilling and completion operations. The facility this well produces into will be modified to allow for the additional wells that are being drilled. Keeping this well down will prevent accidental spills while facility modifications are being made. The well is expected to be back on production November of 2022.
