Matador is filing this sundry to correct the size of the spacing unit to 480 acres. Attached is an updated C102 reflecting the correct spacing unit size. Matador designated this well as the initial well in this horizontal spacing unit. As shown on the attached C102, the well was drilled closer than 330' to the boundary between the E2E2 and W2E2 of this spacing unit, which allowed the formation of this larger 480 acre spacing unit using proximity tracts under NMAC 19.15.16.15.B(1)(b).

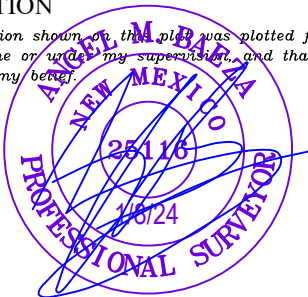

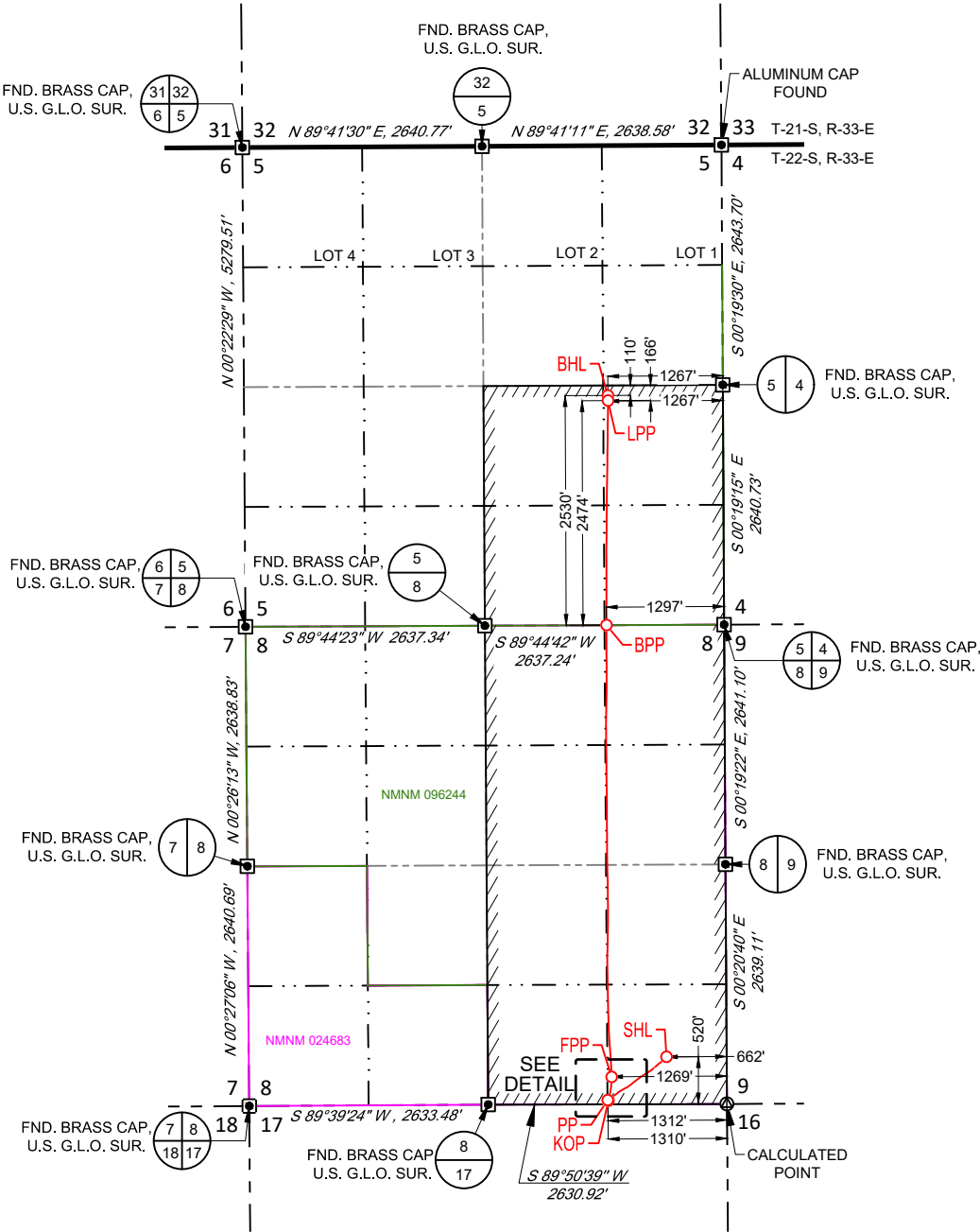

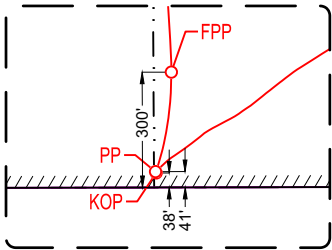
