Matador designated the Dagger Lake South 8 Federal Com #558 (30-025-48831) as the initial well in this horizontal spacing unit. The Dagger Lake South 8 Federal Com #558 was drilling closer than 330' to the boundary between the E2E2 and W2E2 of this spacing unit, which allowed the formation of this larger 480 acre spacing unit using proximity tracts under NMAC 19.15.16.15.B(1)(b).
