Good morning, Greg. Goodnight may test the well as proposed if the results are not intended for use in an IPI application (as identified in SWD-2261; I. D. 1. c.). However, the results of the test should be included with the document for the well completion report (Form C-105). This is significant as this well falls within the scope of the ongoing OCC cases between Empire of New Mexico and Goodnight. I would also remind Goodnight of the obligations for Conditions of Approval required before injection commences including the sampling and testing of formation water prior to injection (including any injectability tests). Additionally, the current extension of SWD-2261 has a deadline of February 16, 2025, to commence injection. If Goodnight encounters issues with completing the obligations or encounter well problems, please provide a written request for an extension prior to the date. The OCD would recommend to the Director a waiver of the 30-day filing requirement (SWD-2261; I. A. 3. a.) considering the well is close to completion.
