Flat Creek Resources respectfully requests a 2 year extension for these APDs. These wells target lower Wolfcamp zones which are higher in gas content. With negative gas pricing in the Permian, these wells are not economic until the gas price recovers. Flat Creek needs additional time to assess its drilling options. The expiration date for all APDs is 3/23/2025.
