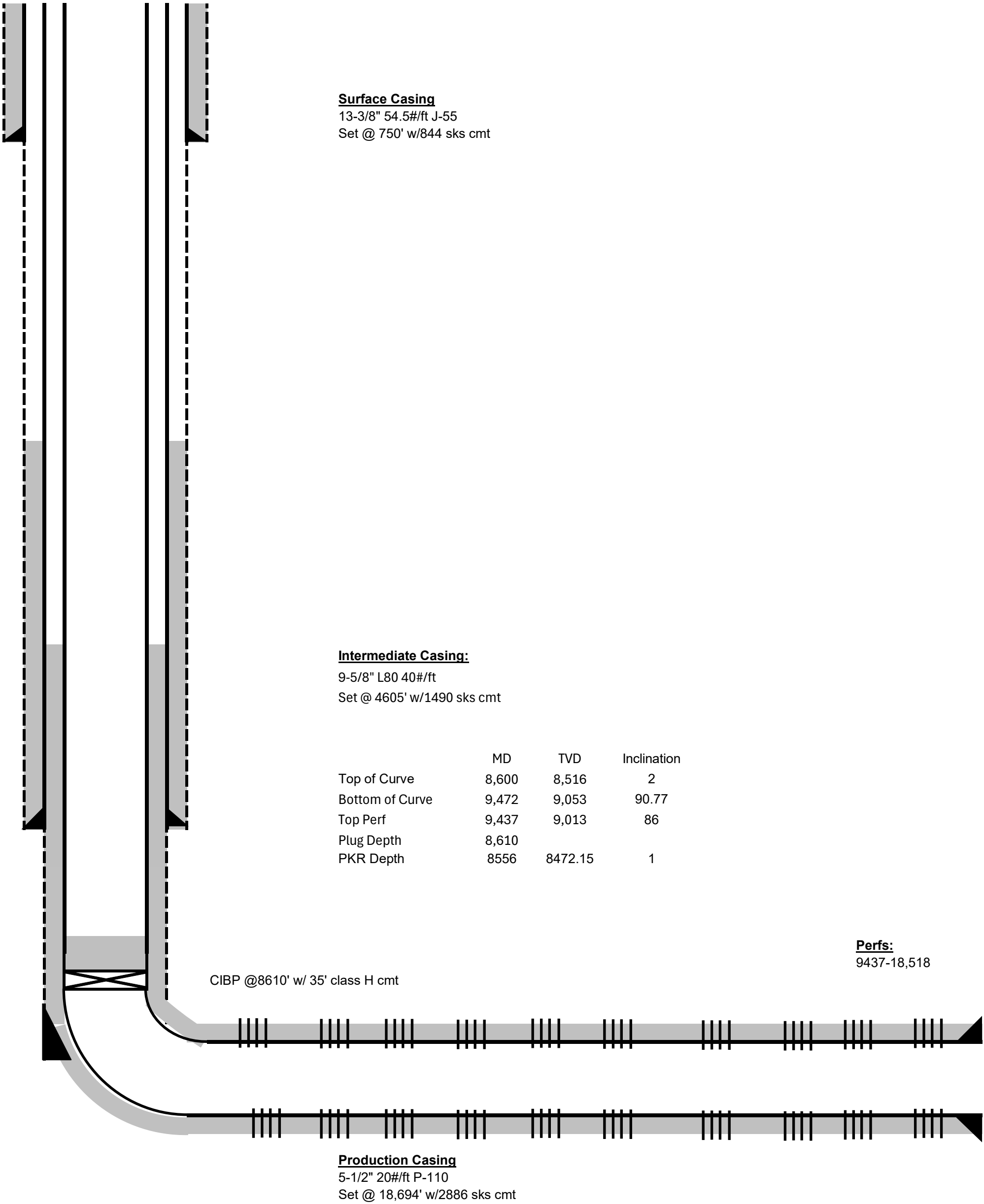
SD WE 24 Federal P23 4H FINAL WELLBORE

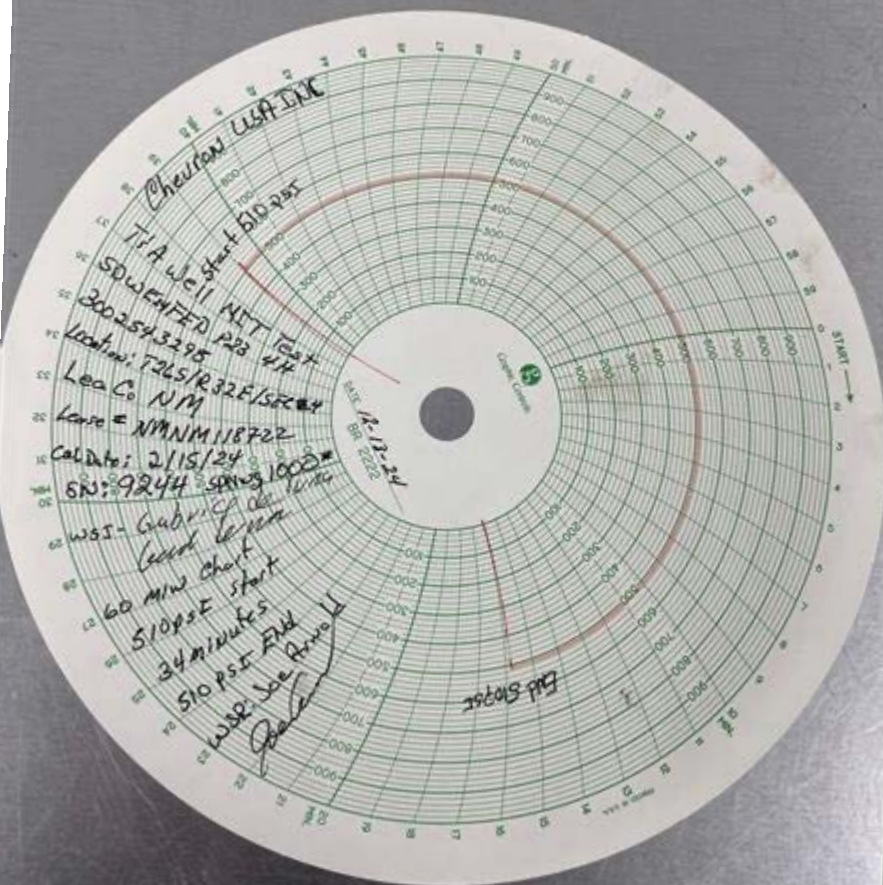
