Plug & Abandonment Procedure:

Note: All cement volumes use 100% excess outside casing and 50' excess inside pipe. Stabilizing wellbore fluid will be 8.33 ppg, sufficient to balance all exposed formation pressures. All cement will be ASTM Class G neat 1.15 ft³/sk or equivalent. If casing pressure tests tagging plugs will not be required. Volumes calculated off 4-1/2" 10.5# casing. NO CBL on file. A CBL will be required. Mechanical integrity will be demonstrated by NMAC 19.15.25.14.

Prior to Mobilization

- 1. Notify BLM & NMOCD
- 2. Verify all cement volumes based on actual slurry to be pumped. Calculations based on 1.15 ft³/sk.
- 3. Comply with all COA's from BLM and NMOCD

P&A Procedure

- 1. MIRU Service Unit and required cement equipment.
- 2. LD horse head. LD stuffing box and polished rods/pump (hot oil if necessary).
- 3. ND WH, NU BOP, RU rig floor and 1-1/2" handling tools.
- 4. POOH laying down 1-1/2" production string set at 7126'.
- 5. PU 2-3/8" workstring and TIH with 4 ½" casing scraper to 7130'. TOOH LD 4 ½" scraper.
- 6. TIH with CICR and set @ 7106'. Roll hole with fresh water. PT tubing to 500 psi. PT casing to 500 psi.
- 1. Plug #1, 7006' 7106' (Dakota top: 7154', Perfs 7156' 7306'): Sting out of CICR, mix & spot 12 sxs (13.8 ft³) of Class G neat cement on top of CICR in balanced plug. PU 200' above plug reverse circulate to clean tubing. WOC and tag plug if casing does not test. Re-spot cement if necessary.
- 2. Plug #2, 5692' 5792' (Gallup top 5742'): Mix & spot 12 sx (13.8 ft³) Class G neat cement in balanced plug. PU 100' above plug and reverse circulate tubing clean. WOC and tag plug if required. PT casing per NMAC 19.15.25.14 if previous test failed. Re-spot cement if necessary.
- 3. Plug #3, 4520' 4620' (Mesa Verde top: 4570')): Mix & spot 28 sx (32.2 ft³) Class G neat cement in balanced plug. PU 100' above plug and reverse circulate tubing clean. WOC and tag plug if required. PT casing per NMAC 19.15.25.14 if previous test failed. Re-spot cement if necessary.

- 4. Plug #4, 3298' 3640' (Chacra & 7.0" INT Shoe): Mix & spot 31 sx (35.65 ft³) Class G neat cement in balanced plug. PU 100' above plug and reverse circulate tubing clean. WOC and tag plug if required. PT casing per NMAC 19.15.25.14 if previous test failed. Re-spot cement if necessary.
- 5. Plug #5, 2530' 2860' (Fruitland/PC): Mix and spot 30 sx (34.5 ft³) Class G neat cement in balanced plug. PU 100' above plug and reverse circulate tubing clean. WOC and tag plug if required. PT casing per NMAC 19.15.25.14 if previous test failed. Re-spot cement if necessary.
- 6. Plug #6, 1680' 1990' (Ojo Alamo/Kirtland): Mix and spot 25 sx (28.75 ft³) Class G neat cement in balanced plug. PUH 100' above plug and reverse circulate tubing clean. WOC and tag plug if required. PT casing per NMAC 19.15.25.14 if previous test failed. Re-spot cement if necessary.
- 7. Plug #7, Surface 485' (9-5/8" Shoe @ 435'): RIH w/ wireline and perforate 3 spf @ 485'. Establish circulation. Pump fluid caliper if required. Mix and pump 106 sx (121.9 ft³) Class G neat or until cement circulates to surface. Top off cement as necessary.
- 7. ND BOP and cut off wellhead below surface casing flange, top off casing and annulus as necessary. Install P&A marker and cut off and/or remove anchors. RD, MOL Restore location per BLM stipulations. Take pictures from all cardinal directions. Ensure to notify project management of all remaining equipment on location once plugging is complete.

The Notice of Intent to Plug and Abandon is accepted with the following Conditions of Approval (COA):

- 1. Plugging operations authorized are subject to the attached "General Requirements for Permanent Abandonment of Wells on Federal and Indian Lease."
- 2. The following modifications to your plugging program are made:
 - a. Add plug to cover BLM geologist's Mancos formation top pick @ 5307'. Plug should cover at a minimum 5357' up to 5207'.
 - b. Adjust Plug 3 (Mesaverde) to cover BLM geologist's Cliff House formation top pick @ 4578'. Plug 3 should cover at a minimum 4628' up to 4478'.
 - c. Adjust plug 5 (Fruitland/PC) to cover BLM geologist's Picture Cliff's and Fruitland formation top picks @ 2730' and 2475', respectively. Plug 5 should cover at a minimum 2780' up to 2425'.
 - d. Adjust Plug 6 (Ojo Alamo/Kirtland) to cover BLM geologist's Kirtland and Ojo Alamo formation top picks @ 1901' and 1662', respectively. Plug 6 should cover at a minimum 1951' up to 1612'.
- 3. Notification: Farmington Field Office is to be notified at least 24 hours before the plugging operations commence at (505) 564-7750.
- 4. **Deadline of Completion of Operations:** Complete the plugging operation before January 31, 2026. If unable to meet the deadline, notify the Bureau of Land Management's Farmington Field Office prior to the deadline via Sundry Notice (Form 3160-5) Notice of Intent detailing the reason for the delay and the date the well is to be plugged.

You are also required to place cement excesses per 4.2 and 4.4 of the attached General Requirements. Any estimated minimum sacks provided in procedure modification include necessary excesses.

GENERAL REQUIREMENTS FOR PERMANENT ABANDONMENT OF WELLS ON FEDERAL AND INDIAN LEASES FARMINGTON FIELD OFFICE

- 1.0 The approved plugging plans may contain variances from the following <u>minimum general</u> requirements.
 - 1.1 Modification of the approved plugging procedure is allowed only with the prior approval of the Authorized Officer, Farmington Field Office.
 - 1.2 Requirements may be added to address specific well conditions.
- 2.0 Materials used must be accurately measured. (densometer/scales)
- 3.0 A tank or lined pit must be used for containment of any fluids from the wellbore during plugging operations and all pits are to be fenced with woven wire. These pits will be fenced on three sides and once the rig leaves location, the fourth side will be fenced.
 - 3.1 Pits are not to be used for disposal of any hydrocarbons. If hydrocarbons are present in the pit, the fluids must be removed prior to filling in.
- 4.0 All cement plugs are to be placed through a work string. Cement may be bull-headed down the casing with prior approval. Cement caps on top of bridge plugs or cement retainers may be placed by dump bailer.
 - 4.1 The cement shall be as specified in the approved plugging plan.
 - 4.2 All cement plugs placed inside casing shall have sufficient volume to fill a minimum of 100' of the casing, or annular void(s) between casings, plus an excess volume sufficient to provide for 50 linear feet of fill above the plug.
 - 4.3 Surface plugs may be no less than 50' in length.
 - 4.4 All cement plugs placed to fill annular void(s) between casing and the formation shall be of sufficient volume to fill a minimum of 100' of the annular space plus 100% excess, calculated using the bit size, or 100' of annular capacity, determined from a caliper log, plus an excess volume sufficient to provide for 50 linear feet of fill above the plug.
 - 4.5 All cement plugs placed to fill an open hole shall be of sufficient volume to fill a minimum of 100' of hole, as calculated from a caliper log, plus an excess volume sufficient to provide for 50 linear feet of fill above the plug. In the absence of a caliper log, an excess of 100% shall be required.
 - 4.6 A cement bond log or other accepted cement evaluation tool is required to be run if one had not been previously ran or cement did not circulate to surface during the original casing cementing job or subsequent cementing jobs.

- 5.0 All cement plugs spotted across, or above, any exposed zone(s), when; the wellbore is not full of fluid or the fluid level will not remain static, and in the case of lost circulation or partial returns during cement placement, shall be tested by tagging with the work string.
 - 5.1 The top of any cement plug verified by tagging must be at or above the depth specified in the approved plan, without regard to any excess.
 - 5.2 Testing will not be required for any cement plug that is mechanically contained by use of a bridge plug and/or cement retainer, if casing integrity has been established.
 - 5.3 Any cement plug which is the only isolating medium, for a fresh water interval or a zone containing a prospectively valuable deposit of minerals, shall be tested by tagging.
 - 5.4 If perforations are required below the surface casing shoe, a 30 minute minimum wait time will be required to determine if gas and/or water flows are present. If flow is present, the well will be shut-in for a minimum of one hour and the pressure recorded. Short or long term venting may be necessary to evacuate trapped gas. If only a water flow occurs with no associated gas, shut well in and record the pressures. Contact the Engineer as it may be necessary to change the cement weight and additives.
- 6.0 Before setting any cement plugs the hole needs to be rolled. All wells are to be controlled by means of a fluid that is to be of a weight and consistency necessary to stabilize the wellbore. This fluid shall be left in place as filler between all plugs.
 - 6.1 Drilling mud may be used as the wellbore fluid in open hole plugging operations.
 - 6.2 The wellbore fluid used in cased holes shall be of sufficient weight to balance known pore pressures in all exposed formations.
- 7.0 A blowout preventer and related equipment (BOPE) shall be installed and tested prior to working in a wellbore with any exposed zone(s); (1) that are over pressured, (2) where the pressures are unknown, or (3) known to contain H_2S .
- 8.0 Within 30 days after plugging work is completed, file a Sundry Notice, Subsequent Report of Abandonment (Form 3160-5), through the Automated Fluid Minerals Support System (AFMSS) with the Field Manager, Bureau of Land Management, 6251 College Blvd., Suite A, Farmington, NM 87402. The report should show the manner in which the plugging work was carried out, the extent, by depth(s), of cement plugs placed, and the size and location, by depth(s), of casing left in the well. Show date well was plugged.
- 9.0 All permanently abandoned wells are to be marked with a permanent monument as specified in 43 CFR 3162.6(d) and 43 CFR 3172.12(a)(10). Unless otherwise approved.
- 10.0 If this well is located in a Specially Designated Area (SDA), compliance with the appropriate seasonal closure requirements will be necessary.

All of the above are minimum requirements. Failure to comply with the above conditions of approval may result in an assessment for noncompliance and/or a Shut-in Order being issued pursuant to 43 CFR 3163.1. You are further advised that any instructions, orders or decisions issued by the Bureau of Land Management are subject to administrative review pursuant to 43 CFR 3165.3 and appeal pursuant to 43 CFR 3165.4 and 43 CFR 4.700.

 water and correlative rights. A CBL must be run or be on file that can be used to properly
 evaluate the cement behind the casing.

Note: Logs must be submitted to OCD via OCD permitting. A copy of the log may be emailed to OCD inspector for faster review times, but emailing does not relieve the operators obligation to submit through OCD permitting.

- 3. Once Plugging operations have commenced, the rig must not rig down until the well is fully plugged without OCD approval. If gap in plugging operations exceeds 30 days, the Operator must file a subsequent sundry of work performed and revised NOI for approval on work remaining. At no time shall the rig be removed from location if it will result in waste or contamination of fresh water.
- 4. Insure all bradenheads have been exposed, identified and valves are operational prior to rig up.
- 5. Fluids must be placed between all cement plugs mixed at 25 sacks per 100 bbls of water.
 - North, water or mud laden fluids
 - South, mud laden fluids
- 6. Closed loop system is to be used for entire plugging operation. Upon completion, contents of steel pits are to be hauled to an OCD permitted disposal facility.
- 7. Class of cement shall be used in accordance with the below table for depth allowed.

- 8. After cutting the well head any "top off cement jobs" must remain static for 30 minutes. Any gas bubbles or flow during this 30 minutes shall be reported to the OCD for approval of next steps.
- 9. Trucking companies being used to haul oilfield waste fluids (Commercial or Private) to a disposal facility shall have an approved OCD C-133 permit.
 - A copy of this permit shall be available in each truck used to haul waste products.
 - It is the responsibility of the Operator and Contractor to verify that this permit is in place prior to performing work.
 - Drivers shall be able to produce a copy upon request of an OCD Compliance Officer.
- 10. Filing a [C-103] Sub. Plugging (C-103P) will serve as notification that the well has been plugged.
- 11. A [C-103] Sub. Release After P&A (C-103Q) shall be filed no later than a year after plugging and a site inspection by OCD Compliance officer to determine if the location is satisfactorily cleaned, all equipment, electric poles and trash has been removed to meet OCD standards before bonding can be released.
- 12. Produced water or brine-based fluids may not be used during any part of plugging operations without prior OCD approval.

13. Cementing;

- All cement plugs will be neat cement and a minimum of 100' in length. 50' of calculated cement excess required for inside casing plugs and 100% calculated cement excess required on outside casing plugs.
- If cement does not exist between or behind the casing strings at recommended formation depths, the casing perforations will be shot at 50' below the formation top and the cement retainer shall be set no more than 50' from the perforations.
- WOC (Wait on Cement) time will be:
 - o 4 hours for accelerated (calcium chloride) cement.
 - o 6 hours on regular cement.
- Operator must tag all cement plugs unless it meets the below condition.
 - The operator has a passing pressure test for the casing annulus and the plug is only an inside plug.
- If perforations are made operator must tag all plugs using the work string to tag unless given approval to tag with wireline by the correct contact from COA #1 of this document.
 - This includes plugs pumped underneath a cement retainer to ensure retainer seats properly after cement is pumped.
- Cement can only be bull-headed with specific prior approval.
- Squeeze pressures are not to exceed the exposed formations frac gradient or the burst pressure of the casing.
- 14. A cement plug is required to be set from 50' below to 50' above (straddling) formation tops, casing shoes, casing stubs, any attempted casing cut offs, anywhere the casing is perforated, DV tools.
 - Perforation/Formation top plug. (When there is less than 100ft between the top perforation to the formation top.) These plugs are required to be started no greater than

50ft from the top perforation. However, the plug should be set below the formation top or as close to the formation top as possible for the maximum isolation between the formations. The plug is required to be a 100ft cement plug plus excess.

- Perforation Plug when a formation top is not included. These plugs are required to be started within 50ft of the top perforation. The plug is required to be a 100ft cement plug plus excess.
- Cement caps on top of bridge plugs or cement retainers for perforation plugs, that are
 not straddling a formation top, may be set using a bailer with a minimum of 35' of
 cement in lieu of the 100' plug. The bridge plug or retainer must be set within 50ft of the
 perforations.
- Perforations are required below the surface casing shoe if cement does not exist behind
 the casing, a 30-minute minimum wait time will be required immediately after
 perforating to determine if gas and/or water flows are present. If flow is present, the
 well will be shut-in for a minimum of one hour and the pressure recorded. If gas is
 detected contact the OCD office for directions.
- 15. No more than 3000 feet is allowed between cement plugs in cased hole and no more than 2000 feet is allowed in open hole.
- 16. Formation Tops to be isolated with cement plugs, but not limited to are:
 - Northwest See Figure A
 - South (Artesia) See Figure B
 - Potash See Figure C
 - o In the R-111-P (Or as subsequently revised) Area a solid cement plug must be set across the salt section. Fluid used to mix the cement shall be saturated with the salts that are common to the section penetrated and in suitable proportions, not more than 3% calcium chloride (by weight of cement) will be considered the desired mixture whenever possible, woe 4 hours and tag, this plug will be 50' below the bottom and 50' above the top of the Formation.
 - South (Hobbs) See Figure D1 and D2
 - Areas not provided above will need to be reviewed with the OCD on a case by case basis.

17. Markers

• Dry hole marker requirements 19.15.25.10.

The operator shall mark the exact location of plugged and abandoned wells with a steel marker not less than four inches in diameter set in cement and extending at least four feet above mean ground level. The marker must include the below information:

- 1. Operator name
- 2. Lease name and well number
- 3. API number
- 4. Unit letter
- 5. Section, Township and Range
- AGRICULTURE (Below grade markers)

In Agricultural areas a request can be made for a below ground marker. For a below ground marker the operator must file their request on a C-103 notice of intent, and it must include the following;

- A) Aerial photo showing the agricultural area
- B) Request from the landowner for the below ground marker.

C) Subsequent plugging report for a well using a below ground marker must have an updated C-102 signed by a certified surveyor for SHL.

Note: A below ground marker is required with all pertinent information mentioned above on a plate, set 3' below ground level, a picture of the plate will be supplied to OCD for record, the exact location of the marker (longitude and latitude by GPS) will be provided to OCD. OCD requires a current survey to verify the location of the below ground marker, however OCD will accept a GPS coordinate that were taken with a GPS that has an accuracy of within 15 feet.

18. If work has not commenced within 1 year of the approval of this procedure, the approval is automatically expired. After 1 year a new [C-103] NOI Plugging (C-103F) must be submitted and approved prior to work.

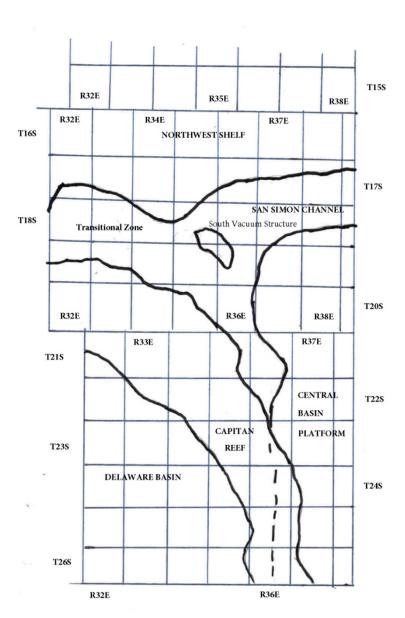
