1/23/2025 Cleared location, set matting board and rigged up. Unseated the pump and laid down the rods. 133 ¾" rods. SION


1/24/2025 Dug out cellar and replaced surface connections. Installed BOP and POOH with tubing. 103 joints 2 3/8" tubing. Made gauge ring run and set 5.5" CIBP at 3280'. RIH with tubing and tagged CIBP. Circulated MLF and tested casing to 550#. Good. Spot 25 sx cement on top of CIBP. POOH and SION.

1/27/2025 Tagged cement at 3019'. Ran bond log. TOC at 2270'. With more cement from 256' to 1068'. Sent bond log to Kieth Immatty with BLM. RIH to 2485' and spot 25 sx cement with CaCl. WOC as per BLM request and tagged at 2234'. POOH to 1076' and spot 25 sx cement. POOH and SION. Will tag in the a.m.

1/29/2025 Tagged cement at 815'. POOH and perforated casing at 240' as per Keith Ammatty with the BLM. RIH with tubing to 391'. Circulated cement inside the 5.5" casing to surface with 40 sx. Closed casing valve and opened the surface valve. Circulated cement to surface inside the 5 ½" X 8 5/8" annulus from perfs at 240' with 40 sx. Rigged down, dug out and removed the wellhead. Topped off both strings of casing with 5 sx cement. Installed standard marker, removed the anchors and cleaned the pit.
