



2. Sqz all perms f/ 4306'-4396' w/ ~500 sx Class C cmt.
3. DO cmt to PBTD 4400'. Pressure test squeeze.
4. Reperf & acidize f/ 4326' to 4396' gross interval.
5. Install injection equipment.
6. Return well to injection.
