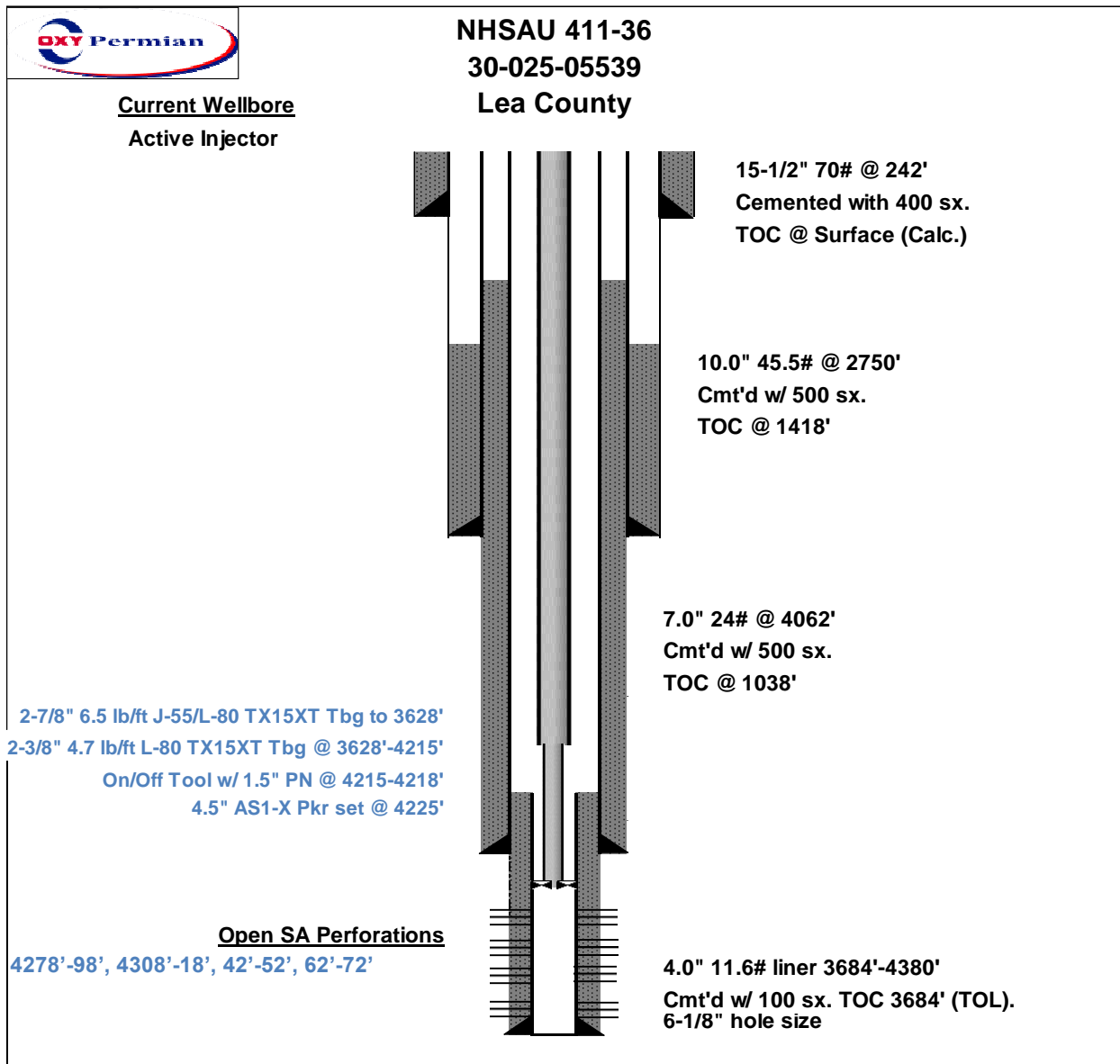

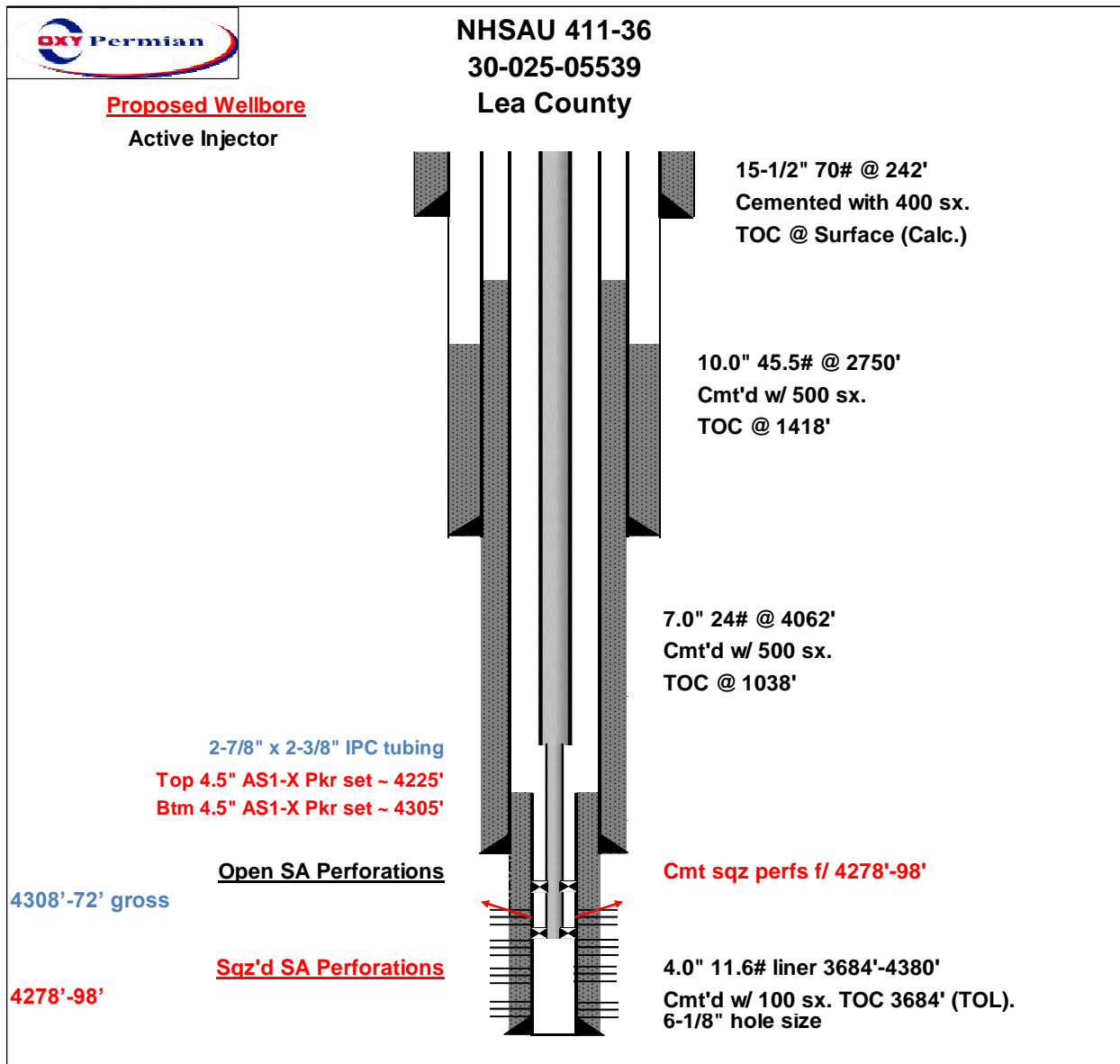

3. DO cmt to PBTD 4380'. Pressure test squeeze.
4. Reperf & acidize f/ 4308' to 4372' gross interval.
5. Install injection equipment.
6. Return well to injection.
