Cement stage 1 with 1410sx lead 11.5ppg 2.26yld 50/50 POZ C and 270sx tail 15.6ppg 1.18yld Class H. Stage 2 with 1000sx lead 11.5ppg 2.26yld 50/50 POZ C and 150sx tail 14.8ppg 1.33yld Class C. Cement did not circulate. Ran temp log and TOC 20' from surface. Email from Allison Morency confirmed that no top out required.
