7/15/2023: Test BOPS. Drill 11 inch intermediate hole to 5570 ft.

7/17/2023: Run 8.625 inch 32 lb J-55 intermediate casing to 5551 ft. Pump 40 bbls water spacer, followed by 850 sks of 11.2 ppg lead cmt, 270 sks of 14.8 ppg tail cmt. Drop plug and displace with 333 bbls fresh water. 143 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

8/21/2023: Drill 7.875 inch production hole to 11245 ft then switch to 6.75 in hole to 21215 ft.

8/29/2023: Run 5.5 inch 20 lb P-110 production casing to 21196 ft MD. Pump 40 bbls gel spacer, then 595 sks of 10.5 ppg lead cmt and 1055 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water, 449 bbls fresh water. 89 bbls returned to surface. Est TOC at 0 ft.
