7/28/2023: Test BOPS. Drill 11 inch intermediate hole to 5594 ft.

7/30/2023: Run 8.625 inch 32 lb J-55 intermediate casing to 5576 ft. Pump 40 bbls water spacer, followed by 845 sks of 11.2 ppg lead cmt, 275 sks of 14.8 ppg tail cmt. Drop plug and displace with 337 bbls fresh water. 147 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

8/10/2023: Drill 7.875 inch production hole to 10061 ft then switch to 6.75 in hole to 20219 ft.

8/19/2023: Run 5.5 inch 20 lb P-110 production casing to 20200 ft MD. Pump 40 bbls spacer, then 510 sks of 10.5 ppg lead cmt and 1040 sks of 13.2 ppg tail cmt. Drop plug and displace with 448 bbls fresh water. 60 bbls returned to surface. Est TOC at 0 ft.

Intermediate Casing Details: Casing ran: 7/30/2023, Fluid Type Brine, 11 inch to 5594 ft, Csg Size 8.625 inch, Weight 32 lbs, Grade J-55, Est TOC 0 ft, Depth set 5576 ft, Cement 1120 sks, Yield 2.60 lead/1.34 tail, Class C, Pressure Held 1500 psi, Pres Drop 0.
