8/4/2023: Test BOPS. Drill 11 inch intermediate hole to 5659 ft.

8/6/2023: Run 8.625 inch 32 lb J-55 intermediate casing to 5549 ft. Pump 30 bbls water spacer, followed by 780 sks of 11.3 ppg lead cmt, 270 sks of 14.8 ppg tail cmt. Drop plug and displace with 335 bbls fresh water. 130 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

8/25/2023: Drill 7.875 inch production hole to 20837 ft.

9/1/2023: Run 5.5 inch 20 lb P-110 production casing to 20813 ft MD. Pump 40 bbls water spacer, then 590 sks of 10.5 ppg lead cmt and 1695 of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water then 441 bbls fresh water. 95 bbls returned to surface. Est TOC at 0 ft.
