**Procedure Description:** XTO Permian Operating LLC respectfully requests a 2-Year APD extension for Poker Lake Unit 22-3 BS 113H. This well is located on a multi-well pad designed for efficient mineral development. The additional time will allow for proper evaluation of completion data on existing wells to enable prudent oil and gas mineral development of multiple zones through reservoir delineation (stacking, spacing, and well count) to maximize production and minimize surface disturbance.
