- Ran CBL Cement to surface.
- Ran in hole with tubing, tagged CIBP @ 1480', mixed 105sx of cement, circulated cement.
- Pulled tubing out of hole, topped casing off, circulated 4 sx to steel pit.
- Checked cement was about 1 1/2' down, cutoff both casings and welded top plate and dry hole marker.



DETAILED DESCRIPTION OF DAY'S OPERATION	
5/15/25	Moved backhoe to location. Dug out wellhead. Started moving equipment to location.
5/16/25	Finished moving equipment to location, laid down rods.
5/19/25	Pulled tubing and made scraper run, set CIBP @ 1480', pressure tested casing to 500 PSI for 30 minutes.
5/20/25	Did CBL, was told to procede with pumping cement, pumped mixed 105 sx of cement, circulated hole, pulled tubing then topped off, circulated 4 sx to pit.
5/21/25	Checked cement, cement about 1 1/2' below wellhead, but above cutoff point.
5/24/25	Cut off casing 3' below ground level and welded on plate and dry hole marker.
