Good test, TIH to 3661', drill out DV tool. Testing casing to 1500psi/5mins. Good test. Circulate. TIH f/3673' t/4800'. Found & change out pinched o-ring on swivel. Drill out cement and lower DV tool f/4800' t/4924'. Circulate. Test 9-5/8" casing to 1500psi/30mins. Good test. TIH drill cement and shoe track & float collar f/6220' t/6428'. Drill new hole f/6428' t/6438'. Circulate hole clean. Perform FIT. Drop gyro. POOH lay down BHA. 11/20 - 11/24/2024 - TIH t/6438'. Drill 8.5" hole f/6438' t/7970'. Rotate & slide drill f/7970' t/21,591' (TD) & perform LCM sweeps as needed. Circulate. 11/25/2024 - Perform clean up cycle. SOOH f/21,591' t/2000'. POOH.
