MIRU WO Rig. POOH w/ rods and tubing.

1. RIH with 4.75" bit and scraper to 8650'. POOH, layed down bit and scraper.

2. Set CIBP @ 8627'. Spotted 35 sx Class H on top of CIBP.

3. Tagged TOC @ 8287'. Loaded hole with 9.5# mud and circulated. Pressure tested to 500 psi for 30 min. Good test.

4. Spotted 25 sx Class C @ 5684'. RIH, tagged TOC @ 5432'.

5. Spotted 46 sx Class C @ 4700'. RIH, tagged TOC @ 4260'.

6. Perfed and Squeezed 28 sx Class C @ 1253'. RIH, tagged TOC @ 1130'.

7. Perfed and Squeezed 35 sx Class C @ 672'. RIH, tagged TOC @ 520'.

7. Perfed and Squeezed 100 sx Class C @ 200'. Verified cement to surface.

On 10/1/2025, Casing was cut off 3' below ground level. A steel plate was welded on top of the casing strings and a dry hole marker was installed. The location has completed remediation to BLM standards.

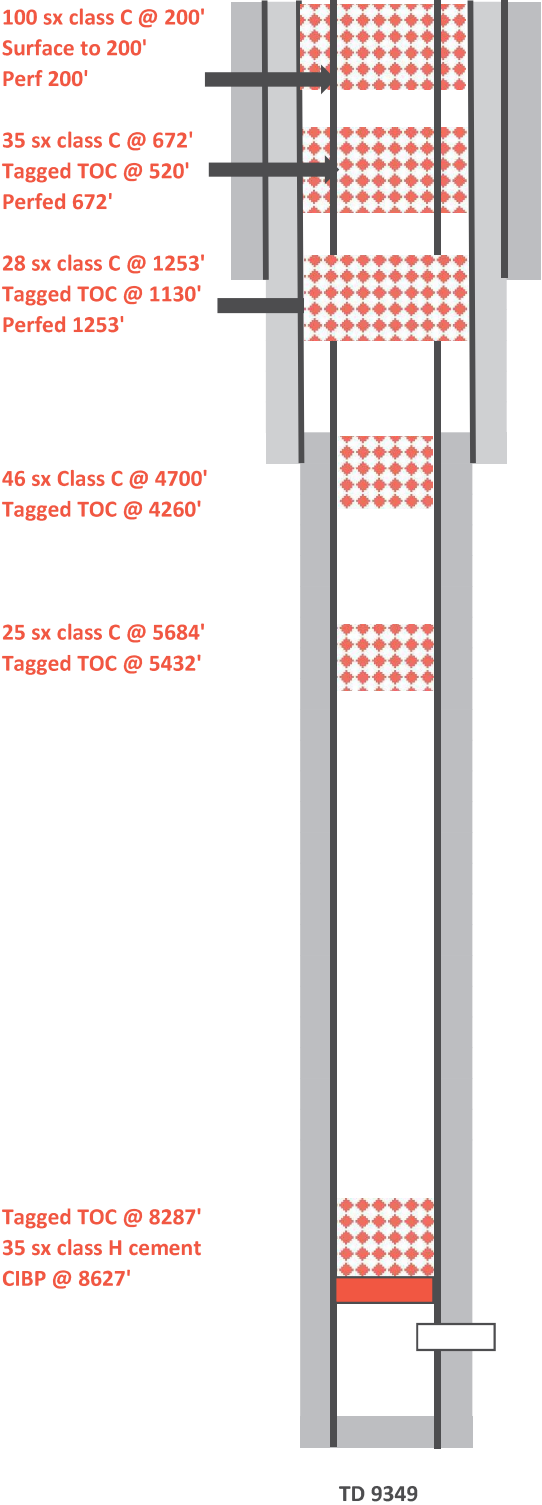
