MOB in on 11/2/25. 11/04/25: Pump kill mud to kill well. ND Wellhead NU BOP. Release Packer. TOO H with injection tubing. 11/5/25: Set CIBP at 5700 feet. Pressure tested. Good test. 11/6/25: MIRU WL and run CBL. RDMO WL. CBL sent to OCD. Spot 30 sacks of class C cement on top of CIBP per instructions from BLM rep Robert Trujillo. Pumped 30 sks of class C cement at 5700 ft. tagged TOC at 5616'. Pulled up to 4735' and spotted balanced plug of 75 sks of class c cement. 11/07/25: Mu to 1050 feet and perforated casing. Established circulation. Set CICR at 775' and squeezed 65 sacks behind & inside casing. WOC and tagged at 775'. 11/8/25: PU to 700 feet shot circ holes at 700 feet, circulated 215 sks of class c cement around 5 1/2" back up 8 5/8" annulus getting cement to surface both sides of casing. Cut off wellhead. Install P&A marker to comply with regulations. Record GPS coordinate for P&A marker on tower report. Photograph P&A marker in place. RDMO.

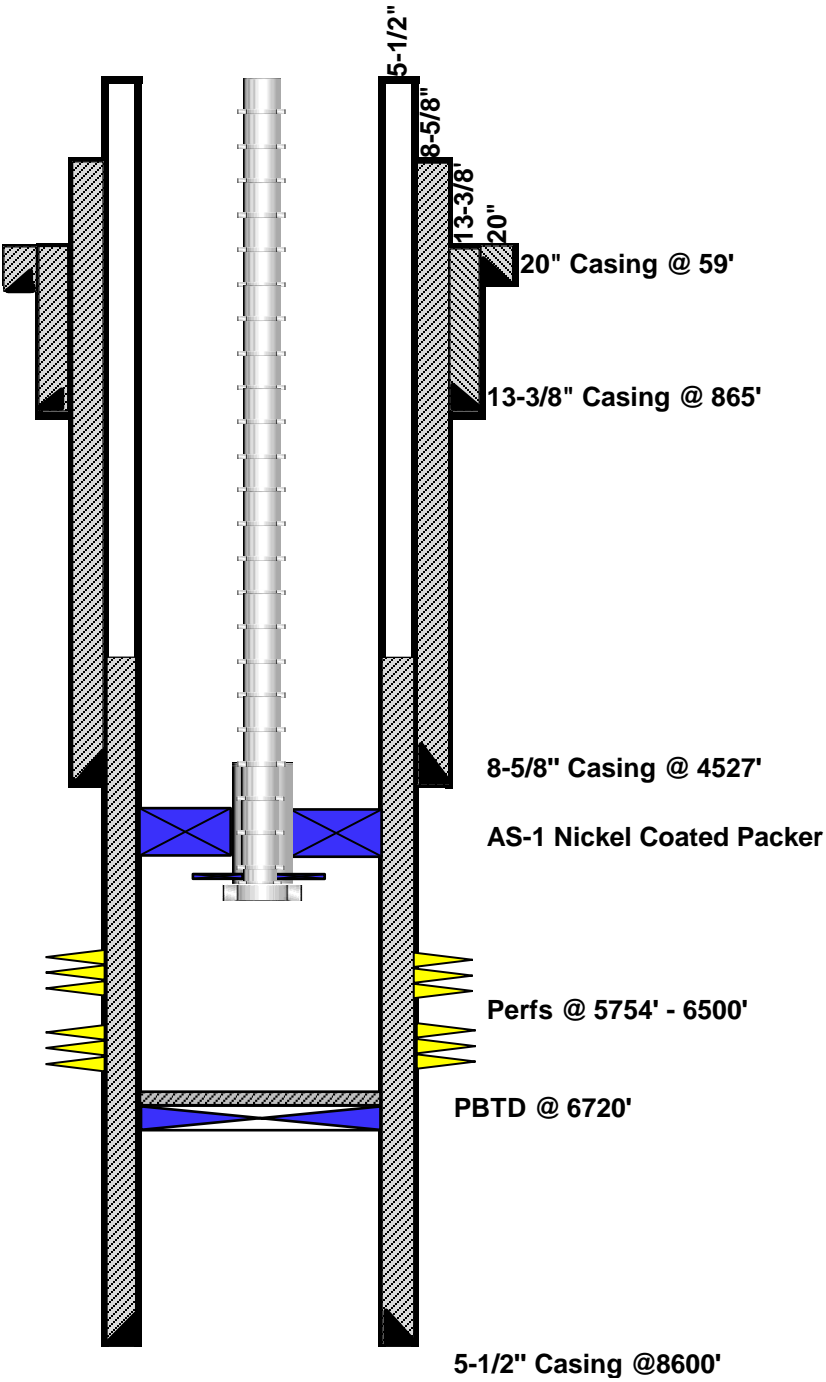

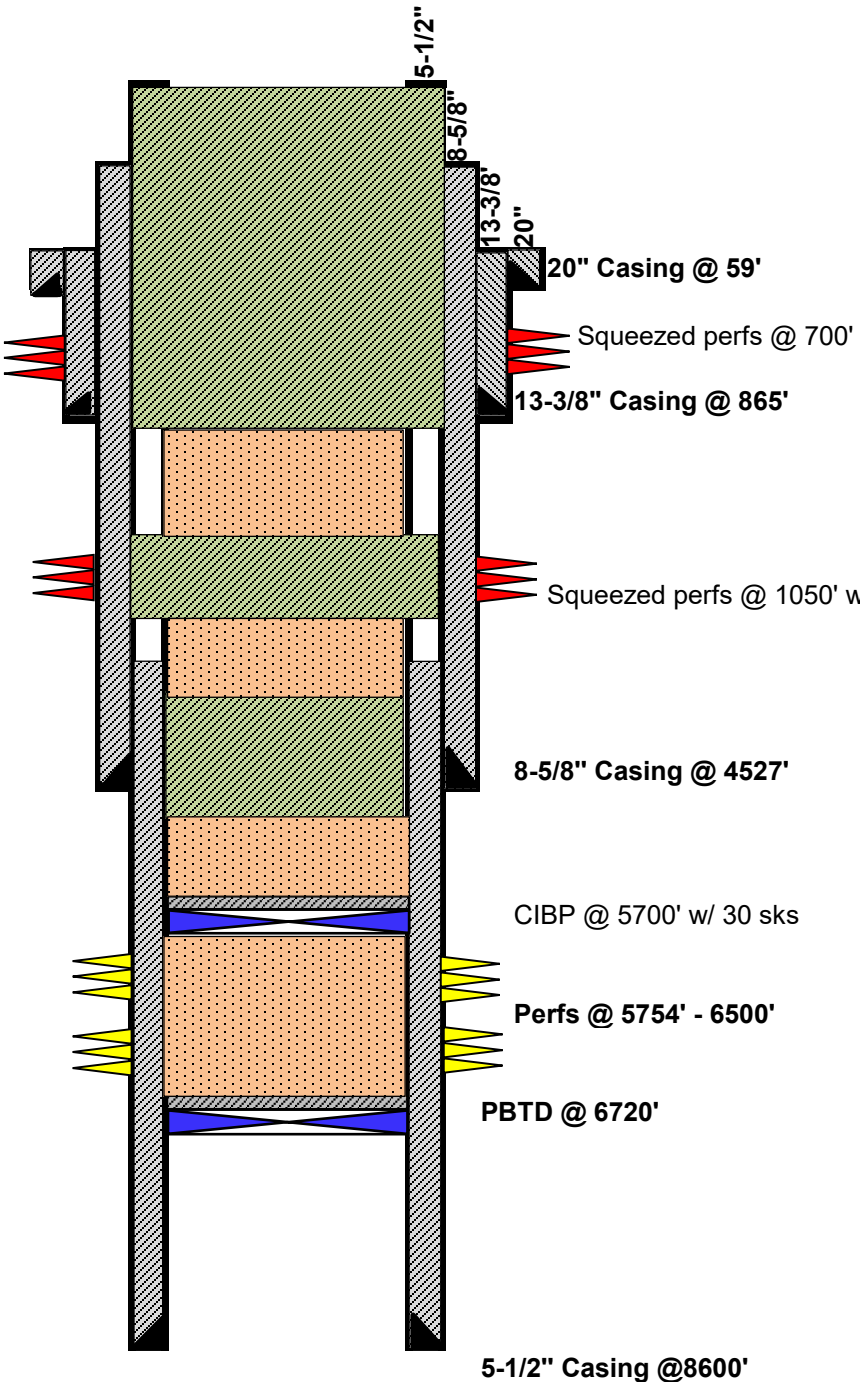
