It is located on an active Mega Pad, 12 feet below ground in a concrete cellar that it shares with another well. It is within 35 feet of an active live well. XTO believes the risk of cutting the well head within the confined below ground and close to an active hydrocarbon source to be higher than the benefit of removing the wellhead and installing the marker at this time.
