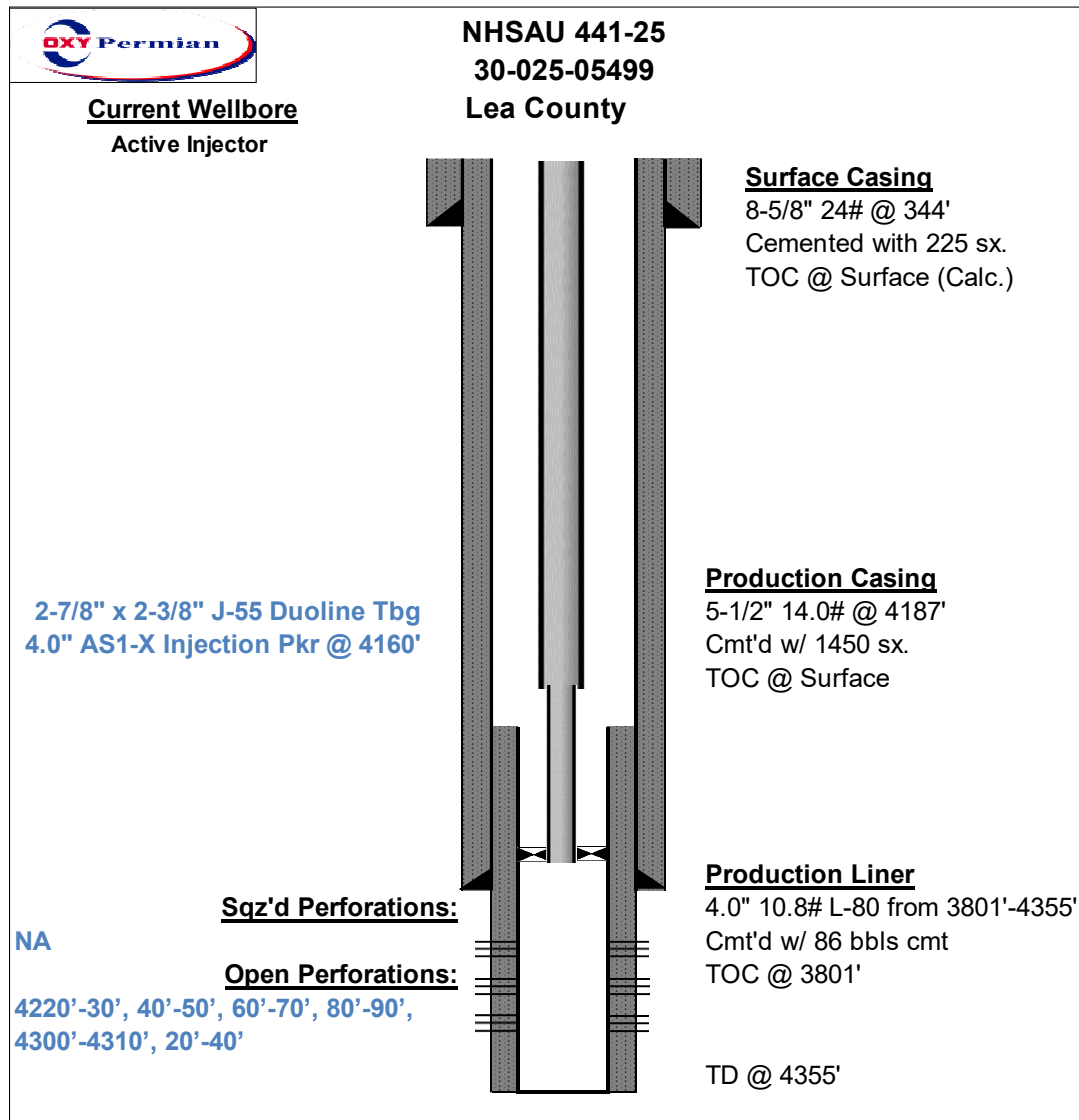

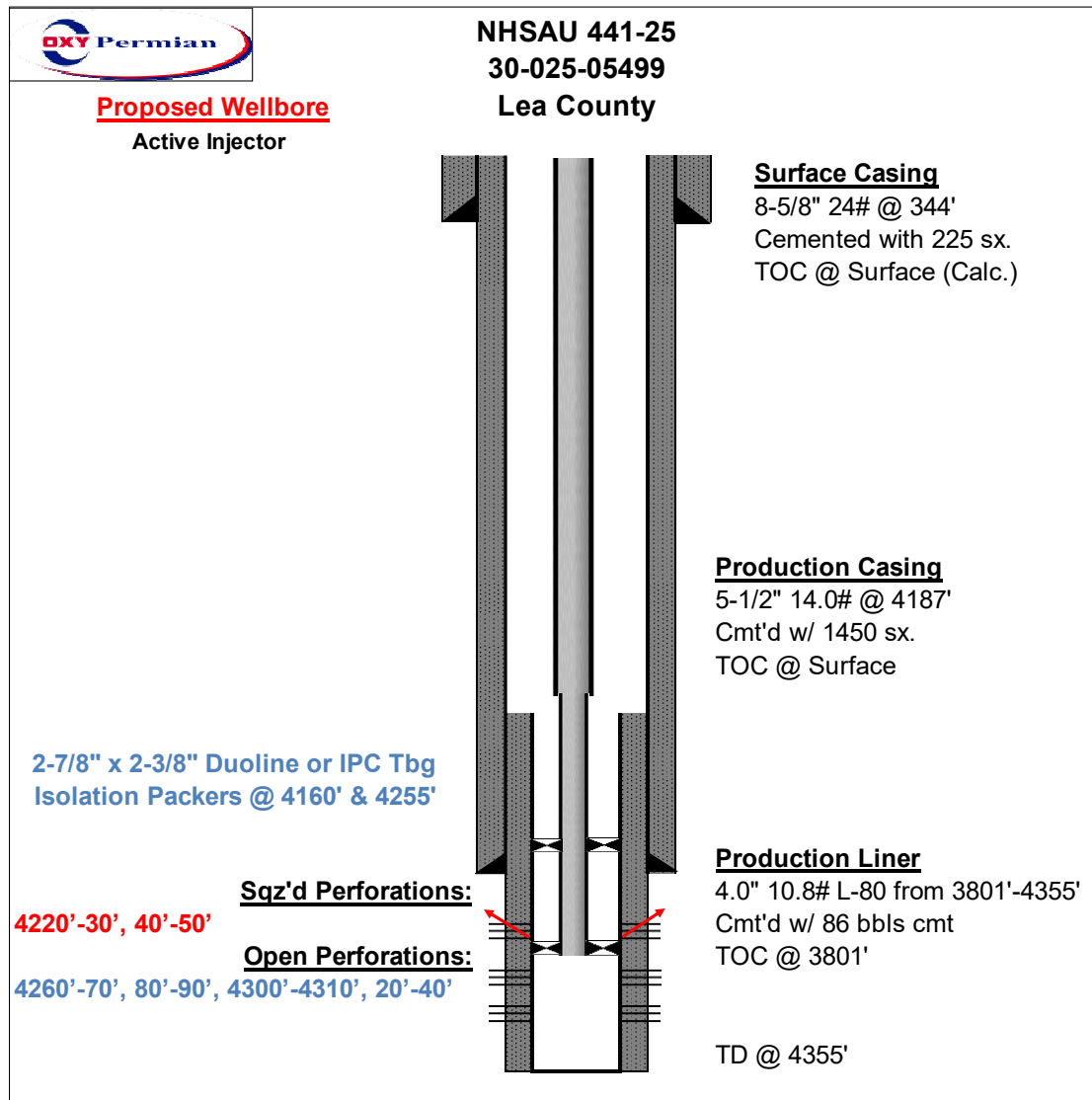
**Job Plan:**

1. Pull injection equipment.
2. Cement Sqz upper perms (Zn2C) f/ 4220'-4250' w/ ~400 sx Class C cmt.
3. DO & Pressure Test Sqz x CO to 4355' PBTD.
4. Reperf & AT lower perforations f/ 4260' to 4340' as required.
5. Install injection equipment including isolation packers ~4160' & 4255'.
6. Perform MIT.
7. Return well to injection.
