

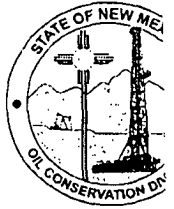

Administrative Order NSP-1952

Re: WBDGU 1930 Well No. 321F
1650 feet FNL & 1650 feet FWL
Section 32, Township 19N, Range 30E, NMPM,
Harding County, New Mexico

Dear Mr. Hughart:

Reference is made to the following:

(a) your administrative non-standard proration unit (NSP) application (**administrative application reference No. pTGW11-03153862**) submitted to the New Mexico Oil Conservation Division (the Division) in Santa Fe, New Mexico on January 31, 2011; and

(b) the Division's records pertinent to your request.

Hess Corporation [OGRID 495] has requested approval of a non-standard 160-acre gas spacing and proration unit in the West Bravo Dome (Tubb) CO₂ Gas Pool (96387), consisting of NW/4 of Section 32, Township 19 North, Range 30 East, NMPM, in Harding County, New Mexico.

The proposed unit will be dedicated to your WBDGU 1930 Well No. 321F (API No. 30-021-20231), located 1650 feet from the North line and 1650 feet from the West line (Unit F) of said Section 32.

Spacing in this pool is governed by the Special Rules and Regulations for the West Bravo Dome Carbon Dioxide Area, as provided in Order No. R-8352 issued in Case No. 7737 on




November 19, 1984, which provide that standard gas units shall consist of 640 acres. Non-standard gas units consisting of less than 640 acres may be established by administrative order, provided that (a) the non-standard unit consists of quarter-quarter sections that are contiguous by a common bordering side, (b) the non-standard unit lies wholly within a governmental section, and (c) the applicant gives required notices to all offset operators and operators of land in the section in which the proposed unit is located that will be excluded from the proposed unit. All of these requirements for an administrative exception for the proposed non-standard unit have been met.

Your NSP application has been duly filed under the provisions of Division Rules 15.11.B(2) and 4.12.A(3) and Rule 3 of the Special Rules and Regulations for the West Bravo Dome Carbon Dioxide Gas Area.

Pursuant to the authority of Rule 15.11.B(2) and Rule 3 of the Special Rules and Regulations for the West Bravo Dome Carbon Dioxide Gas Area, the above-described non-standard 160-acre carbon dioxide gas spacing and proration unit is hereby approved.

Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
