06/11/05 Spud @ 6:30 a.m. Drill 11" surface hole to 346'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 336'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 9 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

06/12/05 Drill 7 7/8" hole from 346' - 2,035'. Reached TD 2,035' at 4:30 p.m. MIRU Patterson and log well. Logger's TD at 2,026'. Run 48 jts 5 1/2", 15.5#, J-55 LT & C casing at 1,990'. HES mixed and pumped 259 sks Midcon II cement. Plug down at 2:04 p.m. Circulated 20 bbls of cement to surface. Shut in. Await completion procedures.
