06/06/05 Spud @ 6:00 a.m. Drill 11" surface hole to 345'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 335'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 8 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

06/07/05 Drill 7 7/8" hole from 345' - 2,335'. Reached TD 2,335' at 6:00 a.m. MIRU Patterson and log well. Logger's TD at 2,336'. Run 55 jts 5 1/2", 15.5#, J-55 LT & C casing at 2,274'. HES mixed and pumped 217 sks Midcon II cement. Plug down at 5:30 p.m. Cement did not circulate due to HES Mechanical problems. Shut in. Await completion procedures.
