On June 9, 2011 the San Juan 29-7 Unit 19th Expansion for the Dakota formation was submitted to our office for approval. The approval for this expansion was on November 1, 2008. The submission of this expansion caused the following Communitization Agreement (CA) to become obsolete due to well's inclusion in the Dakota participating area:

NMNM 122051, Sec. 23, T29N, R7W, W1/2 dedication for San Juan 29-7 Unit No. 67N. Effective 7/4/1997

This agreement communitized particular acres of Federal lands within the San Juan 29-7 Unit as to natural gas and associated liquid hydrocarbons producible from the Dakota formation. The term of the agreement was for 2 years and for so long thereafter as communitized substances were produced in paying quantities.

Our records indicate that the well dedicated to the described agreements was completed and that the public interest requirement for the communitization agreement, pursuant to 43 CFR 3105.2-3, has been met.

The termination effective date of this CA is November 1, 2008, this date being the effective date of the 19th Expansion to the Dakota formation. All subject Federal leases involved with this CA are a part of the Unit. All indicated wells will report to 891001650A (Dakota participating area for the San Juan 29-7 Unit) from the effective termination date of the CA.
