Our records reflect that Canyon E & P Company (OGRID #269864) is the operator of record for the Double L. Queen Unit, Chaves County, New Mexico.

The unit area includes 1,120.02 acres of State Land, 1,231.44 acres of Federal land and 318.64 acres of Fee land for a total of 2,670.10 acres. The term of the agreement was for so long thereafter as unitized substances are or can be produced from the unitized are in paying quantities.

The Bureau of Land Management by their letter of May 8, 2013 advised this office that the Double L. Queen Unit was terminated effective September 30, 2012 being the last day of the month during which unitized substances were produced.

In view of the above, please be advised that the Commissioner of Public Lands has terminated the Double L. Queen Unit Agreement for non-production effective September 30, 2012.
