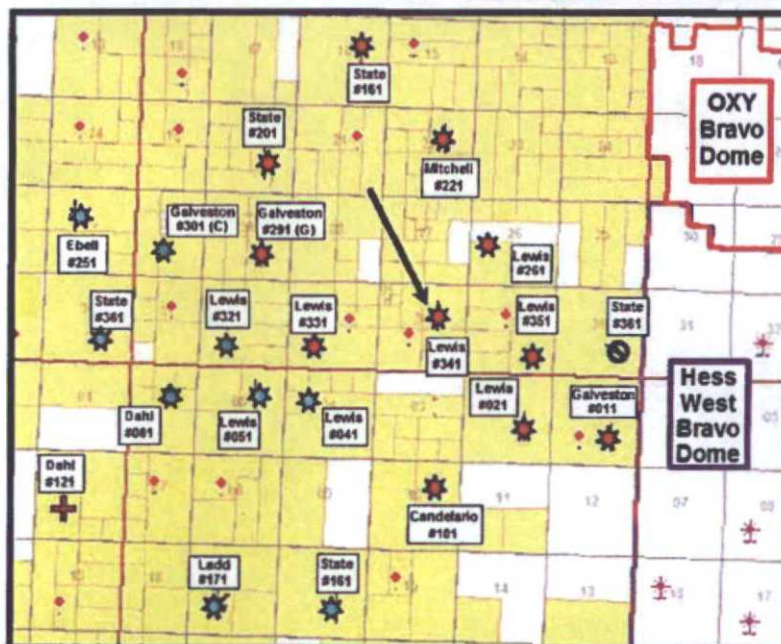

Reasons for Plug and Abandonment:

This is a wildcat well offset to Hess's West Bravo Dome CO2 Unit and OXY's Bravo Dome CO2 Unit. The WeXA pay sands are usually insufficiently developed and often structurally too low to be economical. The Tubb sand in this well had good reservoir pressure but poor quality. The estimated flow rate is too low to justify running a flowline and hooking it to sales.

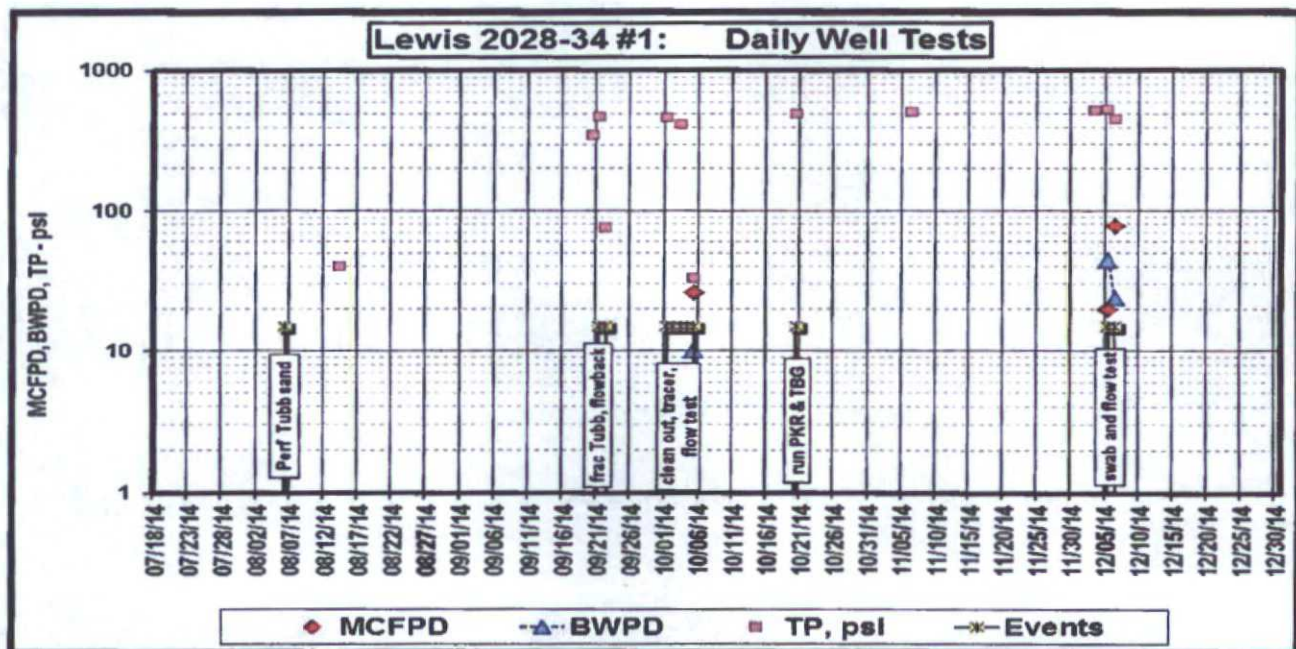

Objective: Plug and Abandon

Basic Procedure:

Renegade ran a CBL on 7-23-14, TOC is 220' and had a good bond. (Cement circulated, but fell back). A pressure survey was run on August 20th, 2014: surface was 350 psi and BHP was 450 psi and no FL was detected. After-frac casing pressure built up to 530 psi, but with low flow rate. Last well work was in December 2014 (swab) and rig anchor tests should be current.

- Bleed off any pressure and pump brine to kill the well. Unseat the packer and pooh. LD all EQPT and send to the Wickett yard.
- Set a 5-1/2" CIBP @ 2600' and cap with 35'+ cement by bailer.
- Load hole w/ 10 PPG salt gel mud.
- Dig out the 9-5/8" casing and check the annulus for any pressure.
- Pump a 35 sx plug across the 9-5/8" casing shoe from 571' to 771'. Pump a 25 sx FW plug from 300' to 500'. Shoot SQZ perfs at 50', or as directed. If the NMOCD requires tags, it may be faster and cheaper to just fill the casing to surface with cement.
- Pump 20 sx and fill casing and annulus from 50' to the surface.
- Fill in the annulus around the 9-5/8" at the surface with cement as needed.
- Remove the wellhead and weld on cap with standard dry - hole marker.
- Cut off rig anchors and smooth location. Remove fences and caliche as needed

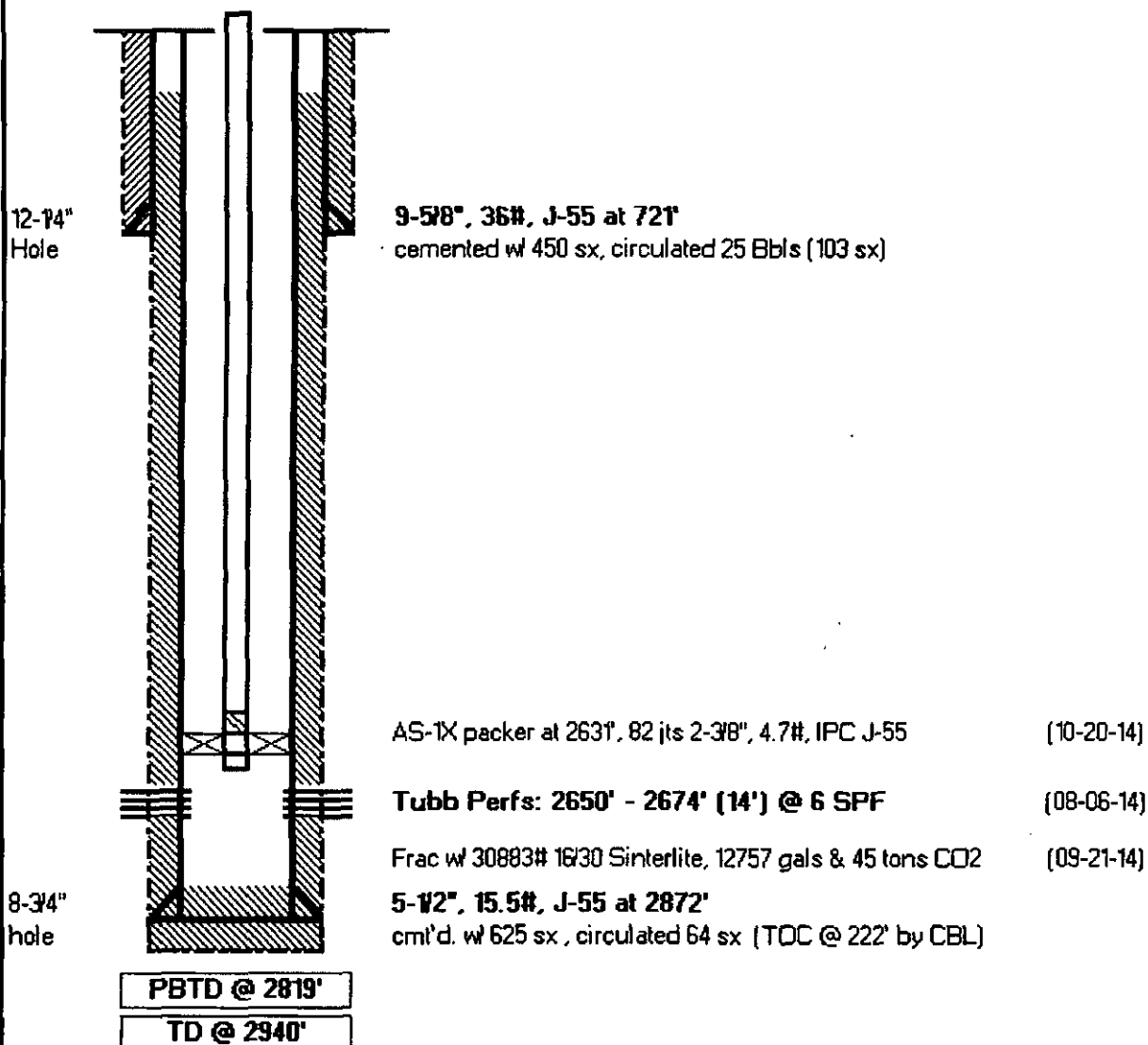

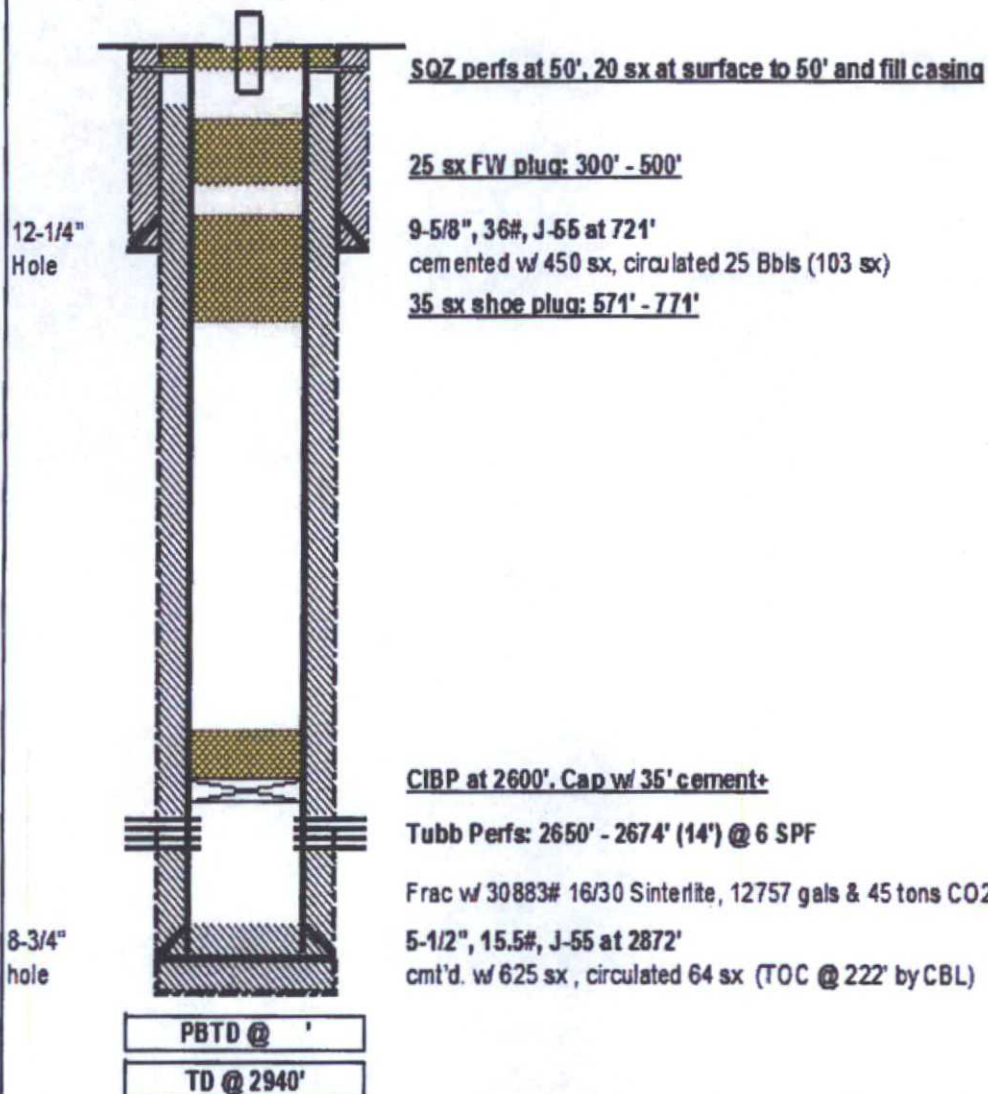
