

- A. - B. Approve the attached Communitization Agreement covering sec. 22, E2E2, T. 25 S., R. 26 E., NMPM, as to all producible hydrocarbons from the Bone spring formation. This approval will become invalid if the public interest requirements under section 3105.2-3 (e) are not met.
