MI RU single pole rig  
 Set 5 1/2" CIBP at 1958' (approximately 50' above top perms)  
 Spot 10 sx. Class A cement on top of CIBP (calc 51' fillup, top of plug at 1958")  
 Spot cement plug inside 5 1/2" casing across casing surface shoe from 526' to 296' with 45 sx Class A Cement (calc 230' fillup, top of plug at 296')  
 TOH, wait 4 hours, TIH and tag plug and record depth  
 Spot cement plug inside 5 1/2" casing at surface from 100' to surface with 30 sx Class A Cement. (cement to surface)  
 Cut off wellhead and install P&A Marker in accordance with NMOCD guidelines  
 RD MO rig. remove all equipment from site.  
 Restore site.
