Dear Mr. Stone:

Reference is made to your request on behalf of OWL SWD Operating, LLC ("operator") to extend the February 25, 2016 deadline stipulated in order SWD-1536 to commence drilling operations for the above referenced well for an additional six months for reasons outlined in the attached correspondence. The first extension was issued January 22, 2016, and extended the deadline to August 25, 2016.

Paragraph nine of the administrative order contains a condition of approval that stipulates a deadline to spud the referenced well. This condition is the result of an agreement between the operator and the potash company with mineral interests at the well's location.

As required in the order, the Division has been provided confirmation by the Mosaic Potash Company that it has no objections to another six-month extension of the order for the referenced well.

Additionally, it is the Division's understanding from your request that there have been no significant changes in the information provided in the application submitted for review and approval of this order.
