Reference is made to your request on behalf of MRC Permian Company ("MRC") received by the Division on October 12, 2016, for the Paul 25 24S 28E RB Well No. 121H (API No. 30-015-43011; "proposed well") with a surface location in Unit D of Section 25, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico.

It is our understanding that MRC still intends to drill the proposed well but is unable to meet the obligation date of December 31, 2016, included in Ordering Paragraph (5) of Order No. R-14082. MRC has stated that additional time is required due to scheduling constraints

The Division has reviewed your request and hereby extends the final date to commence the drilling of this well to July 1, 2017. All other provisions of Order No. R-14082 remain in full force and effect.


Dear Mr. Catanach:

On December 8, 2015, the NMOCD issued Order R-14082 creating a 160-acre non-standard oil spacing and proration unit for oil production from the Bone Spring formation to be dedicated to Matador Production Company's ("Matador") Paul 25 24S 28E RB Well No. 121H (the "Well"). On account of scheduling constraints, Matador has moved the Well to next year's drill schedule.

Accordingly, pursuant to paragraph 5 of Order R-14082, Matador respectfully requests that the NMOCD grant it an extension, up to and until July 1, 2017, to commence drilling operations on the Well and thereafter continue drilling the Well with due diligence to test the Bone Spring formation.
