05/26/06 Spud @ 10:00 a.m. Drill 11" surface hole to 340'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 329'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 5 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

05/27/06 Drill 7 7/8" hole from 340' - 2,755'. Reached TD 2,755' at 7:30 p.m. MIRU Patterson and log well. Logger's TD at 2,598'. Run 63 jts 5 1/2", 15.5 #, J-55 LT & C casing at 2,515'. HES mixed and pumped 413 sks Midcon II cement. Circulated 17 bbls cement to surface.
