06/22/06 Spud @ 7:30 a.m. Drill 11" surface hole to 311'. Run 10 jts. of 8 5/8", 24#, J55 ST & C casing at 302'. Halliburton mixed and pumped 100 sk Midcon II cement, 14 ppg, yield 1.66. Circulated 2 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

06/23/06 Drill 7 7/8" hole from 311' - 2,935'. Reached TD 2,935' at 3:00 p.m. MIRU Patterson and log well. Logger's TD at 2,899'. Run 71 jts 5 1/2", 15.5 #, J-55 LT & C casing at 2,775'. HES mixed and pumped 385 sks Midcon II cement. Circulated 21 bbls of cement to pit.
