05-20-03 Mack Drilling spudded the corehole. Drilled a 7 7/8" hole to 320'. Ran 4 1/2" surface casing to 309'. Cemented casing with 35 sks of Midcon II. Circulated 30 gallons to cement. to surface.

05-23-03 MIRU Dynatec. Drilled cement out to casing shoe.

05-29-03 Continuous core to TD at 1401'. Schlumberger ran platform express log. Logger's TD = 1400'. Ran 45 jts of 2 3/8" tubing and seating nipple at 1386'. Mixed and pumped 80 sks of Midcon II cement with 6% salt, 5# gilsonite, 2% versaset, 3 % super CBL, .25 lb/sk flocele. Cement circulated to surface.
