02/19/07 Spud @ 4:30 a.m. Drill 11" surface hole to 262'. Run 10 jts. of 8 5/8", 24 #, J55 ST & C casing at 318'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 5 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

02/20/07 Drill 7 7/8" hole from 262' - 2485'. Reached TD 2485' at 6:00 a.m. MIRU Superior and log well. Logger's TD at 2672'. Run 56 jts 5 1/2", 15.5 ppf, J-55, and 7 jts 17 ppf, J-55 LT&C casing at 2256'. HES mixed and pumped 294 sks Midcon II cement. Circulated 4 bbls of cement to surface.
